Good morning,

See the answers below:

- 1) Yes. There was an additional expense in July. I've attached all legal expenses in 2018 for review. Part of these expenses include the Corporate Annual Report that is required annually by the Department of State Division of Corporations.
- 2) No. Through July 2018 there has been no Bad Debt Expense recorded
- 3) In October 2017, the future 1,000 ERCs were removed from the Administrative portion of the contract since it is unlikely that these will be reached in the immediate future. Also, actual expenses were utilized for the Administrative Vehicle Fuel and Maintenance consistent with recent Commission decisions. It should be noted that a fully comprehensive audit of actual costs for all contracts for all of the investor owned utilities was recently conducted. We anticipate revising all contracts in the very near future (estimate within the next month). Based on this review and analysis Pine Harbour is still receiving a subsidy of around \$372 annually. The revised contract for Pine Harbour will be going up slightly. Also, this anticipated increase includes adding back the 1,000 future ERCs due to the financial impact on the regulated IOUs. It was also discovered that in the previous original contract for Pine Harbour there was not enough employee staff (FTEs) included for the actual work being performed in that region.
- 4) I have instructed the maintenance manager to go ahead and schedule the replacement due to the current condition of the fence. I do not have an anticipated replacement date but anticipate it being completed within the next few months, if not sooner.
- 5) No retirement amount has been contemplated. However, in the transfer order Order No. PSC-2017-0043-PAA-WU, the total amount of plant in Account 304 Structure and Improvements was \$2,869. Since this was in existence at the time of the acquisition it is unknown what constitutes this amount. However, it is believed to include the small chemical shed and fence. If the normal 75% is utilized this will retire almost the entire amount that was approved in the transfer Order.
- 6) No. However, this may have been previously included in either Account 304 or Account 330 by the previous owner since they were installed on the outside of the ground storage tank and water treatment plant. These were three outdoor flood lights and an indoor timer for the electrical supply.
- 7) This was a potion of the screen and lattice on around the top of the ground storage tank where the aeration is located. it is believed that this was part of the storage tank previously recorded in Account 330 by the previous owner.
- 8) It is not anticipated to request any additional pro forma plant for Pine Harbour.

- 1. Has Pine Harbour incurred any expenses for legal services from 3/17/18 to the present? If yes, please provide a copy of the invoices and proof of payment.
- 2. Has Pine Harbour recorded any bad debt expense for 2018? If yes, please provide documentation for those expenses.
- 3. What subsidies were minimized in the revised October 1, 2017 Operation and Maintenance Agreement?
- 4. When does Pine Harbour estimate the water treatment plant fence replacement project will be completed?
- 5. Has Pine Harbour determined a retirement value for the existing four foot high water treatment plant fence that will be replaced with a higher six foot fence? If yes, please provide documentation for the estimated retirement value and indicate if the retirement is based on original cost or a 75 percent retirement value. If a 75 percent retirement value will be used, please provide an estimated retirement value based on an estimated project cost to replace the four foot fence with a similar four foot fence if possible.
- 6. Has Pine Harbour determined a retirement value for the water treatment plant light and timer replacements? If yes, please provide documentation for the estimated retirement value and indicate if the retirement is based on original cost or a 75 percent retirement value.
- 7. If the storage tank screen repair project included the replacement of any plant items, please provide the retirement value for the replaced items and indicate if the retirement is based on original cost or a 75 percent retirement value.
- 8. Is Pine Harbour planning to request consideration of any other pro forma repairs or replacements in this SARC? If yes, please provide the invoices or quotes, and indicate when the projects either were or will be completed.
