PLEADING IN RESPONSE OF THE NOTICE OF PROPOSED AGENCY ORDER IMPOSING PENALTIES AND COLLECTION COSTS AND REQUIRING the PAYMENT OF DELINQUENT REGULATORY ASSESSMENT FEE

BeCruising Telecom LLC dba BECRU, through his legal counselor and BeCruising Telecom Manager as filing parties request the kindly consideration of the elimination of the penalty and/or reconsideration of the costs imposed based on the following facts and issues.

### Antecedents facts and issues:

- BeCruising Telecom LLC paid in January 2019 a check number 1003 for \$600 dated Jan 30 2019. See attached check copy and Annual Report sent to avoid any penalty. ( Attachment A)
- 2) The check was processed but was returned on a letter of Florida PUblic Commission with the Annual Report at the end of February, because the report presented with the check did not have TY116. See Letter of February and Annual Report with wrong information proceed and check of \$600 processed. ( Attachment B)

However, the mistake to confuse BeCruising Telecom LLC with other company should not have happened because in the Annual Report theBeCruising Telecom LLC

company is identified with the FEI ID number 27-2832316, and the original docket 1500180 TX assigned by the FI Public Service Commision when the licence was issued. That docket number was present in the check too. That was a mistake of paperwork but we sent the check and report on January 2019.

- 3) Ms. Roig is the manager in charge of the report and had an accident and was not working for some weeks. It is the reason because the report was not sent before January 31 of 2019. Please see attached medical report. (Attachment C)
- 4) Ms Roig called FI Public Commission for information to understand what to do. According to the information received: Becruising Telecom LLC sent a money order to substitute the check of the 600 and sent a check for the penalty for \$708. In addition, Becruising Telecom LLC representative requested the reconsideration of the penalty and costs. was explained that in the Order that would be issued on May 8 Becruising Telecom will have the opportunity to make the pleading. See attached copy of the money order and check for penalty that already was cashed. (Attachment D)

### CONSIDERATIONS:

- a) Considering that the manager had an accident and was not working and on therapy.
- b) Considering that BECRUISING TELECOM sent the first check on January 2019 with the Annual Report but it was returned because of a paperwork problem,
- c) Considering that the amount owed for 2018 was already paid before the order was issued in addition of a check to cover any potential penalty or cost.

As a result: Becruising Telecom LLC dba BECRU requests the elimination of the penalty and costs and the return of the amount of the check 1002 sent for \$708 that has already been cashed.




