Pursuant to Section 186.801, Florida Statutes, the Florida Public Service Commission (Commission) is responsible for reviewing and classifying each electric utility's Ten-Year Site Plan as "suitable" or "unsuitable." As part of the annual review, in accordance with Rule 25-22.071, Florida Administrative Code, the Commission must provide a copy of the relevant Ten-Year Site Plans (TYSP) to, and solicit the views of, the appropriate state, regional, and local agencies. To this end, the Commission has made available on its website electronic copies of the 2019 TYSPs for all the Florida electric utilities at the following link: <http://www.psc.state.fl.us/ElectricNaturalGas/TenYearSitePlans>.
