The Governor's office forwarded a copy of your correspondence regarding Duke Energy Florida (DEF) to the Florida Public Service Commission (FPSC). The FPSC regulates investor-owned electric, and natural gas utilities throughout the state, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the FPSC. The FPSC has limited authority in the telephone industry to include the Lifeline Assistance Program, Florida Relay Service, and pay telephone service. You expressed concern about DEF's petition for limited proceeding for recovery of incremental storm restoration costs related to Hurricane Dorian and Tropical Storm Nestor.

On February 4, 2020, the FPSC approved an interim storm restoration recovery surcharge allowing DEF to recover costs related to 2019 Hurricane Dorian and Tropical Storm Nestor. With FPSC's approval, a monthly residential 1,000 kilowatthour customer bill will increase \$5.34—effective March 2020 through February 2021. The interim storm restoration recovery charge is subject to refund with interest pending FPSC review of the utility's actual restoration costs. The disposition of any over or under recovery, and interest, will be considered by the FPSC at a later date.
