**SECTION 63.71 APPLICATION  
OF AVAYA CLOUD INC.**

Avaya Cloud Inc. ("Applicant") seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to grandfather and discontinue the sale of Zang Office and accompanying products in all states and jurisdictions where the service is offered. Applicant will cease to provide Zang Office products and services, along with technical support, to customers currently under contract on September 30, 2020. Applicant will suggest alternative services to customers, and waive all cancellation fees associated with termination of services. Applicant will further refund all customers pro-rated fees associated with any pre-payments received for the balance of the customer's term.

Subject to Commission authorization, on September 30, 2020, Applicant will prohibit new customers from ordering these services. Modifications in service offerings for customers with existing contracts are subject to the terms of their contracts. Applicant plans to discontinue these products and services completely after September 30, 2020. Customers will be able to obtain alternative services and products from Avaya Cloud or other providers that perform the same functions as these services.

Applicant submits the following information pursuant to Section 63.71 of the Commission's rules:

**1. Name and Address of the Carrier**

**2. Date of Planned Service Discontinuance**

As of September 30, 2020, or as soon thereafter as the necessary regulatory approvals can be obtained, Applicant will no longer offer its Zang Office products and services to new customers or accept new orders from existing customers (except to the extent such orders are permitted by contract). Applicant is working with customers with contracts for the affected services to transition them to alternative services after their contracts expire.

**3. Points of Geographic Areas of Service Affected**

Subject to the Commission's Authorization, Applicant will discontinue the provision of its Zang Office products and services in all 50 states, the District of Columbia, and Puerto Rico.

**4. Description of Services Affected**

Applicant's Zang Office offering is a cloud-based business phone service that includes interconnected Voice over Internet Protocol (VOIP), voice mail, call holding, transfer & forward, pickup, park, caller ID, fax, DND and extension dialing from any extension or any device.

**5. Brief Description of the Dates and Methods of Notice to All Affected Customers**

Customers that are currently subscribed to the affected services were provided notice on or before July 7, 2020. Copies of the notifications are attached to this application as Attachment A.

Also, on July 7, 2020, Applicant sent copies of this Application via electronic mail or First Class Mail to the public utility commission and to the Governor of each affected state, federally- recognized tribal nations in each state, the Commonwealth of Puerto Rico, and the Secretary of Defense, Attention Special Assistant for Telecommunications, as required by Section 63.71(a) of the Commission's rules.

**6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued**

Applicant is considered non-dominant with respect to the services to be discontinued.

**CONCLUSION**

The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advanced notice has been provided to all affected customers who will continue to receive services under the existing contracts through the contract term. Customers have also been given ample time to arrange substitute services, which are already available in the marketplace, upon expiration of their existing contracts. Therefore, Applicant respectfully requests that the Commission approve this Section 63.71 application.
