The Company is claiming confidentiality of Jeffery S. Chronister's Exhibit JSC-1, attached to his direct testimony and portions of Exhibit MDW-1 attached to the direct testimony of Mark Ward under Section 366.093(3)(d) and Section 366.093(3)(e), F.S.

Per the Statute, proprietary confidential business information includes, but is not limited to; Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

The information provided in Exhibit JSC-1 for which confidential treatment is being sought can be described as completion dates, liquidated damages received, and how liquidated damages were assigned. The information provided in Exhibit MDW-1 for which confidential treatment is being sought can be described as the cost of major equipment including solar panels and transformers, and the balance of the system equipment and EPC contractor cost.

Staff has reviewed the information TECO filed in Exhibit JSC-1 and in Exhibit MDW-1. It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Section 366.093(3)(d), F.S. and Section 366.093(3)(e), F.S.
