PURPOSE AND PROCEDURE:

The purpose of this hearing is to consider the petitions submitted by Florida Public Utilities Company related to its storm-cost recovery for Hurricanes Michael and Dorian, and to consider Florida Public Utilities Company's petition for approval of 2019 depreciation study. The Commission may also consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; and (2) allow for such other purposes as the Commission may deem appropriate.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on August 28, 2020. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

It shall be the responsibility of counsel to provide their clients, client representatives, and witnesses with the invitation, which will allow them to access the hearing. Counsel for each party will also be provided the call-in number for audio participation.

Any member of the public who wants to observe or listen to the proceedings may do so by accessing the live video broadcast the day of the hearing, which is available from the FPSC website. Upon completion of the hearing, the archived video will also be available.

JURISDICTION

This hearing will be governed by Chapter 366 in addition to Chapter 120, Florida Statutes, and Rules 25-22 and 28-106, Florida Administrative Code.
