Staff has reviewed PODs 25 and 28 included in the responses to staff's 9th request for PODs (No. 25) with BS 17,144-17,161, (No. 28) with BS 17,162, and (No. 29) with BS 17,163 and , and in staffs opinion, the request meets the criteria for confidentiality contained in Section 366.093, F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 11130-2020 and 11346-2020 be approved pending recommendation of PODs 29.
