Duke Energy Florida, LLC (“DEF” or the “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of documents provided in DEF’s Response to the Office of Public Counsel’s (“OPC”) First Request to Produce (Nos. 1-4). The confidential responses have been filed with the clerk and the redacted versions have been submitted as part of DEF’s Responses to the respective requests.
