- 4. Please provide information on the number of customers that pay their monthly electric bill with more than one payment, including more than one credit card payment (i.e., the same monthly bill is paid off over several payments).
- 5. Regarding the holidays excluded from the on-peak periods in the time-of-use tariffs, please provide the basis for the specific holidays stated in the time-of-use tariffs and state whether DEF considered revising the holidays.
