REQUEST FOR NAMING OF QUALIFIED REPRESENTATIVE

Pursuant to Rules 28-106.106 and 28-106.107, Florida Administrative Code, the Smart Thermostat Coalition (“STC”), an *ad hoc* coalition of leading smart thermostat manufacturers, requests that Madeline Fleisher, an attorney with the law firm Dickinson Wright PLLC, be named a qualified representative for STC in all docketed and non-docketed matters before the Florida Public Service Commission (“Commission”).

3. STC submits that Ms. Fleisher possesses the necessary qualifications to responsibly represent STC’s interests in matters before the Commission. In this regard, Ms. Fleisher’s qualifications are set forth in the attached affidavit.

4. As reflected in Ms. Fleisher’s affidavit, she: (i) is an attorney admitted to practice in the State of Ohio, (ii) has reviewed those portions of the Florida Statutes relative to the Commission’s jurisdiction, (iii) has reviewed the Florida Rules of Civil Procedure relating to

discovery in an administrative proceeding, and (iv) has reviewed those portions of the Florida Administrative Code and Florida Statutes related to the rules of evidence, including the concept of hearsay in an administrative proceeding.

5. Consistent with the standard set forth in Rule 28-106.106, F.A.C., Ms. Fleisher has acquired or will acquire actual knowledge of the factual and legal issues involved insofar as her representation of STC is concerned in matters before the Commission.

WHEREFORE, for the above and foregoing reasons, STC respectfully requests that this Request for Naming of Qualified Representative be granted.
