Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO or Company) requests confidential classification for certain highlighted information contained in responses to staff's third request for PODs (Nos. 6-19).

The Company is claiming confidentiality for certain highlighted information appearing in Document No. 07862-2021 under Section 366.093(3), F.S. Per the referenced Statute, propriety of confidential business information includes, but is not limited to: Subsections (d) "Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information." The highlighted information provided in Document No. 07862-2021 for which confidential treatment is being sought consists of 1.) details of Tampa Electric's competitive and strategic approaches to asset optimization, and 2.) The identities of specific Tampa Electric customers and data regarding their energy consumption. The Company asserts that disclosure of this information would be harmful to the competitive interests of the individual Tampa Electric customers.

Staff has reviewed the information provided in the highlighted portions of the Company's response to staff's third request for PODs (Nos. 6-19) as well as the Company's confidentiality request (Document No. 07861-2021). In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3), F.S. Therefore, staff recommends that the request for confidentiality of information included in Document No. 07862-2021 be approved.
