applied to separate the costs of the plant in service for the primary and secondary voltage distribution FERC Accounts, including FERC 364, FERC 365, FERC 366, FERC 367, and FERC 368. Then an assessment was made of the subsequent Derivation of Unit Cost report that is shown on page 28 of the Cost-of-Service Study. Specifically, the monthly amounts of the customer-related costs for each rate class were evaluated in comparison to the comparable results of the cost-of-service study approved in the 2013 rate case filing. The customer-related cost component consists of MDS, meters, meter reading, billing, and customer services. The combined increases of these cost components moved the total customer cost amount materially higher than the total customer cost determined in the previous rate case filing.
