**GULF POWER COMPANY'S
FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION**

Pursuant to Section 366.093, Florida Statutes (“F.S.”), and Rule 25-22.006, Florida Administrative Code (“F.A.C.”), Gulf Power Company ("Gulf") hereby submits its First Request for Extension of Confidential Classification of certain material provided in response to the Office of Public Counsel’s (“OPC”) 1st Set of Interrogatories, No. 15, and OPC’s 1st Request for Production of Documents (“PODs”), Nos. 1, 2, 6, 9-15, 18 and 20 ("Confidential Information"). In support of this Request, Gulf states as follows:

1. On January 10, 2020, Gulf filed a Motion for Temporary Protective Order, pursuant to Section 366.093, F.S., and Rule 25-22.006, F.A.C., pertaining to Gulf’s response to OPC’s 1st Set of Interrogatories (No. 15) and 1st PODs (Nos. 1, 2, 6, 9-15, and 18) (Document No. 00188-2020).
2. On January 31, 2020, Gulf filed a Request for Confidential Classification, pursuant to Section 366.093, F.S., and Rule 25- 22.006, F.A.C., pertaining to Gulf’s response to OPC’s 1st Set of Interrogatories (No. 15) and 1st PODs (Nos. 1, 2, 6, 9, 10, 18, and 20) (Document No. 00737-2020).
3. On March 2, 2020, Gulf filed an Amended Request for Confidential Classification and Motion for Temporary Protective Order. In that filing, Gulf clarified that it was requesting confidential treatment for Gulf’s responses to OPC’s 1st Set of Interrogatories, No. 15, and 1st PODs, Nos. 1, 2, 6, 9-15, 18, and 20. In other words, Document Nos. 00188-2020 and 00737-

2020 are identical. By Order No. PSC-2020-0120-CFO-EI, dated April 21, 2020 ("Order 0120"), the Commission granted Gulf's March 2, 2020 Request. Gulf adopts and incorporates by reference the March 2, 2020 Request and Order 0120.

4. The period of confidential treatment granted by Order 0120 will soon expire. The Confidential Information that was the subject of Gulf's March 2, 2020 Request and Order 0120 warrants continued treatment as proprietary and confidential business information within the meaning of Section 366.093(3), F.S. Accordingly, Gulf hereby submits this First Request for Extension of Confidential Classification.

5. All the information designated in Exhibits A and B to the March 2, 2020 Request remain confidential. Accordingly, those exhibits are not reproduced or reattached to this filing.

6. Included as First Revised Exhibit C is the justification table, in which the name of a former declarant, Mitchell Goldstein is replaced with the name of a current declarant, April Epperson. Included as First Revised Exhibit D are the declarations of Paul Talley and April Epperson in support of this request.

7. The Confidential Information is intended to be and has been reared by Gulf as private, its confidentiality has been maintained, and its disclosure would cause harm to Gulf and its customers. Pursuant to Section 366.093, F.S., such information is entitled to continued confidential treatment and is exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.

8. As further detailed in the declaration included as First Revised Exhibit D, certain documents contain information concerning internal auditing controls and reports of internal auditors. This information is protected by Section 366.093(3)(b), F.S.

9. In addition, the documents or materials contain information concerning contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms. Specifically, the information contains benchmarking analyses which Gulf is required to maintain as confidential by contractual agreement. This information is protected by Section 366.093(3)(d), F.S. This information also relates to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. This information is protected by Section 366.093(3)(e), F.S.

10. Upon a finding by the Commission that the Confidential Information remains proprietary and confidential business information, the information should not be declassified for a period of at least eighteen (18) months and should be returned to Gulf as soon as the information is no longer necessary for the Commission to conduct its business. See § 366.093(4), F.S.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials and affidavits included herewith, Gulf Power Company respectfully requests that its First Request for Extension of Confidential Classification be granted.



1. My name is April Epperson. I am currently employed by Gulf Power Company ("Gulf") as Controller. I have personal knowledge of the matters stated in this written declaration.

2. I have reviewed the documents and information included in Gulf's Request for Confidential Classification filed this date, for which I am listed as a declarant on Exhibit C. The documents that I have reviewed and which are asserted by Gulf to be proprietary confidential business information contain or constitute contractual data, and information related to competitive interests, the disclosure of which would impair the competitive business of Gulf, its affiliates and its contractors, vendors and suppliers. Specifically, the documents and exhibits contains the names, rates, quantity, contractual provisions, invoices of our third-party contractors, vendors and suppliers, payments to our contractors, vendors and suppliers, all of which was agreed upon exclusively with these contractors, vendors, and suppliers. The documents further describe the specific methodologies developed and used by Gulf to negotiate contracts, to secure resources, to receive, review and approve or reject requests for payment, and every other aspect of Gulf's unique processes developed and used by Gulf in responding to storm events, obtaining resources, and administering payment processes related thereto. Disclosure of this information would impair Gulf's contractor, vendor, and supplier relationships, and impair or negate the commercial interests of Gulf as Gulf negotiates contracts and seeks to obtain contractors, vendors and suppliers to provide critical construction, restoration resources necessary to perform storm restoration. Disclosure of this information would also impair or negate the commercial interests of Gulf's contractors, vendors and suppliers as they negotiate with others for the services they provide. The disclosure of this information will also impact the efforts of Gulf or its affiliates to contract for goods and services on favorable terms in the future, which in turn increases costs to Gulf and its customers. To the best of my knowledge, Gulf has maintained the confidentiality of this information.

3. Consistent with the provisions of the Florida Administrative Code, such materials should remain confidential for a period of eighteen (18) months. In addition, they should be returned to Gulf as soon as the information is no longer necessary for the Commission to conduct its business so that Gulf can continue to maintain the confidentiality of these documents.

4. Under penalties of perjury, I declare that I have read the foregoing declaration and that the facts stated in it are true to the best of my knowledge and belief.
