Good day, my name is Kevin Tyler; I am a property owner and live on Palm Island full time. The central sewer proposal in question would have a direct effect on me.

I am requesting that you deny EU's Application for Original Certificate of Authorization for this proposed central sewer system for the following reasons:

- Wildly fluctuating cost estimates EUs estimates for hookup fees and average monthly bills
 are all over the map, starting with outrageous and going up. These expenses appear to be
 open-ended as all cost overruns will inevitably be passed along to homeowners
- **Competence** The fluctuating cost-estimates indicate to me that EU lacks the project-management skills to make this happen according to any reasonable plan. They certainly have no particular expertise operating a central sewer system.
- Complexity The proposed system is needlessly complex and proposes to push financial and
 maintenance responsibility for critical components of the system onto the homeowners. It is
 not yet clear who would be responsible for these pumps, but as proposed, homeowners would
 provide electrical infrastructure required to operate lift pumps. With such a complicated system
 and responsibility distributed among EU and homeowners, this design is needlessly
 complicated and is certain to be fragile and prone to failures.

This is a half-baked proposal by an inexperienced waste processing company with unlimited potential for economic and environmental harm. I urge you to reject EU's application.
