**RE: NUSO, LLC - INTENTION TO OBTAIN NUMBERING RESOURCES IN THE STATE OF Florida**

Pursuant to the Federal Communications Commission’s (FCC) 15-70 Order<sup>1</sup>, allowing interconnected VoIP providers to obtain resources directly from the North American Numbering Plan Administrator and/or the Pooling Administrator, we hereby notify the Commission of our receipt of FCC numbering authorization<sup>2</sup>.

In compliance with Federal rules NUSO hereby notifies this Commission of its intent to request the resources identified below. We are providing this notice at least 30 days prior to requesting numbers from the Numbering Administrators<sup>3</sup>.
