FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL
CLASSIFICATION OF CERTAIN INFORMATION PROVIDED IN
ITS SECOND SUPPLEMENTAL RESPONSE TO OFFICE OF PUBLIC
COUNSEL'S FIRST REQUEST FOR PRODUCTION OF DOCUMENTS (No. 13)

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") hereby submits its First Request for Extension of Confidential Classification of certain information provided in its second supplemental response to the Office of Public Counsel's ("OPC") First Request for Production of Documents No. 13 (the "Confidential Information"). In support of its Request, FPL states as follows:

- 1. On May 4, 2021, FPL filed a Request for Confidential Classification of Confidential Information, which included Exhibits A, B, C and D (May 4, 2021 Request"). Document No.03900-2021. By Order No. PSC-2021-0286-CFO-EI, dated July 29, 2021 ("Order 0286"), the Commission granted FPL's May 4, 2021 Request. FPL adopts and incorporates by reference the May 4, 2021 Request and Order 0286.
- 2. The period of confidential treatment granted by Order 0286 will soon expire. The Confidential Information that was the subject of FPL's May 4, 2021 Request and Order 0286 warrants continued treatment as proprietary and confidential business information within the meaning of Section 366.093(3). Accordingly, FPL hereby submits its First Request for Extension of Confidential Classification.
- 3. All of the information designated in Exhibits A and B to the May 4, 2021 Request remains confidential. Accordingly, those exhibits will not be reproduced or reattached here. Regarding First Revised Exhibit C, all of the information listed in the May 4, 2021 Request

remains confidential; the Exhibit is revised only to identify Scott Bores as a new declarant who is sponsoring information that was previously sponsored by Robert Barrett.

- 4. Also included is First Revised Exhibit D, which consists of the declaration of Scott Bores.
- 5. The Confidential Information is intended to be and has been treated by FPL as private, its confidentiality has been maintained, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093, such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.
- 6. As described in the declaration included as Exhibit D, the Confidential Information consists of proprietary confidential business information, the disclosure of which would cause harm to FPL's customers and its business operations. Specifically, some information contains data related to equity analyses of utilities performed by third party vendors, the disclosure of which would impair the competitive interests of the provider of the information. This information is protected by Sections 366.093(3)(e), Fla. Stat.
- 7. Upon a finding by the Commission that the Confidential Information is proprietary confidential business information, the information should not be declassified for a period of at least an additional eighteen (18) months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. *See*§ 366.093(4), Fla. Stat.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials and declarations, FPL respectfully requests that its First Request for Extension of Confidential Classification be granted.

I have reviewed the documents referenced and incorporated in FPL's Request for Confidential Classification, specifically the materials provided in the Second Supplemental response to Office of Public Counsel's First Request for Production of Documents No. 13. The documents or materials that I have reviewed and which are asserted by FPL to be proprietary confidential business information contain competitive business information the disclosure of which would impair the competitive business of the provider of the information. Specifically, the information relates to equity analyses of utilities performed by third party vendors, the disclosure of which would impair the competitive business of the provider of the information.
