Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

The information provided for which TECO seeks confidential treatment can be described as contractual payments and rates between TECO and Pasco County used in several examples for their Purchased Power Agreement. Also included are contract termination payment values and the Pasco Transmission Cost Cap value.

Staff has reviewed the Company's documents and confidentiality request. In staff's opinion, the information that is the subject of TECO's request meets the criteria for confidentiality contained in 366.093(3)(d), F.S.
