Complaint: Delay in Service against Florida Power & Light Company

Details:

My Compliant is with you, the PUC. I live in Destin where Gulf Power was recently acquired by FPL (NextEra Energy) and our rates went up 30% and continue to go up with some BS story from the PUC about how they will go down in the future.

Here is my problem.
