Pursuant to Section 366.093, Florida Statues (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO or Company) requests an extension of confidential classification of certain information filed in the above-referenced docket, dated April 8, 2022. The initial confidential classification was granted pursuant to Order No. PSC-2022-0162-CFO-EI.¹

The Company is claiming confidentiality of its filing under Section 366.093(3)(d), F.S., and Section 366.093(3)(e), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

More specifically, the information at issue relates to email correspondence between TECO and General Electric (GE) regarding negotiations for forensic engineering/root cause analysis services related to an outage of Polk Unit 1. The subject information also contains confidential price quotations prepared by GE.

Staff has reviewed the Company's subject information and confidentiality request. It is staff's opinion that the information subject to this request continues to meet the criteria for confidentiality contained in Section 366.093(3)(d), F.S. and Section 366.093(3)(e), F.S.
