1 PROCEEDINGS 2 All right. If everyone could CHAIRMAN FAY: 3 grab their seats. 4 Okay. We will call the December 5th Special 5 Agenda Conference to order. Mr. Hampson, we will have you introduce the 6 7 item this morning. You are recognized. 8 MR. HAMPSON: Thank you. 9 Good morning, Commissioners. This is Corey 10 Hampson on behalf of Commission staff. 11 At the November 9th, 2023, Special Agenda, the 12 Commission approved Peoples Gas System revenue 13 requirement as shown in Attachment A to the 14 recommendation. The Commission also voted on 15 issues addressing the forecast of customers and 16 therms, depreciation, rate base, cost of capital, 17 net operating income and cost of service. 18 Today, we are here to discuss Peoples Gas 19 System rates and tariffs, and specifically Issues 20 60, 61, 69, 70 and 75, which were not voted on at 21 the November 9th Special Agenda. 22 Issue 60, customers charges, and Issue 61, per 23 therm gas distribution charges, have been 24 calculated based on the Commission-approved total 25 revenue requirement for Peoples Gas.

1 Staff recommends approval of the customer 2 charges and per therm distribution charges as shown 3 in Attachment B to the recommendation. 4 In Issue 69, staff recommends the -- that the 5 Commission should approve the tariffs provided in Peoples Gas has provided a direct 6 Attachment B. 7 notice to customers during December 2023 and January 2024, which identifies the final 8 9 Commission-approved rates and charges. As stated in Issue 70, staff recommends that 10 11 the proposed rates and charges should become 12 effective with the first billing cycle of January 13 2024. 14 Lastly, in Issue 25 -- or excuse me, 75 -staff recommends that after the final order is 15 16 issued, this docket should be closed. 17 This is a post-hearing decision, and 18 participation is limited to Commissioners and 19 staff. 20 Thank you. 21 CHAIRMAN FAY: Okay. Great. Thank you, Mr. 22 Hampson. 23 Commissioners, let's -- what we All right. 24 will do is we will take up, as Mr. Hampson 25 mentioned, Issues 60, 61, 69 and 70. Those are all
