

Re: NC Real Estate Projects LLC d/b/a Grenelefe Utility – Increase in meter installation fees

Dear Mr. Maurey,

In an attempt to modernize and bring system improvements and updates to the recently acquired Grenelefe system, the new owners are undertaking a complete change out of meters to only utility radio read meters going forward. While the cost of this complete system change out will be accounted for in a rate case request in a separate proceeding, the utility finds itself in immediate need of a new meter installation fee in order to recognize the fact that the utility no longer installs anything other than radio read meters for new service from this point forward.

As such, I am attaching hereto a revised tariff sheet 19.0 showing the change to the tariff needed in order to recognize the cost of radio read meters for all new meter installations. I am also attaching a copy of a quote for the complete meter change out wherein the cost per meter of \$265 is shown. We have contacted a utility contractor who has stated that the install cost will be \$333.90 per meter and including parts and labor. As such we are seeking a new meter installation fee of \$600 for 5/8 by 3/4" and actual cost for all larger sizes.

Attached are two copies of the proposed revised tariff and to recognize this new meter installation fee. Please approve the new tariff as quickly as possible as the utility is already in need of a revised tariff to recognize the change in meter installation costs.

3/4 by 5/8 inch meter curb stop \$93.95 3/4 by 5/8 inch meter coupling \$54.95 Single water meter box \$30.00 Dual check valve \$25.00 1 trip charge \$65.00 1 hour labor \$65.00

Total materials and labor cost is \$333.90. This price obviously does not include the meter itself which is \$265.00.

The total cost for a new install would be \$598.90 or rounded up is \$600.00.
