By this letter, Commission staff respectfully requests that Peninsula Pipeline Company, Inc. (Peninsula) and Florida City Gas (FCG) provide responses to the following questions.

- 1. Will FCG purchase the alternative natural gas directly from the owners and/or operators of each landfill or from third party suppliers?
- 2. Referring to paragraphs 14, 17, and 20 of the petition, is the producer of gas different or separate from the landfill owner or operator? Please explain.
- 3. Will FCG include the cost of the purchased landfill gas in the next Purchased Gas Adjustment proceeding?
- 4. Please discuss the cost differences between purchasing natural gas from locally produced alternative gas (i.e., landfill gas) and from traditional out of state gas sources.
- 5. Please discuss for each project all other options FCG considered to bring additional gas into the area.
