Dear Commissioners:

I implore you to deny this request by Environmental Utilities (EU).

Please put your self in our shoes.

The VAST amount of homeowners on these islands have perfectly functioning septic systems. The DON'T require electricity to operate. Many of these septic systems are practically new (and at a great cost to each homeowner). They are tested and approved by Charlotte County — and comply with all the current rules and regulations.

Please imagine if you can another storm like Helen or Milton. We as Islanders certainly can. The island is under water again. Only this time, we have potentially thousands of ELECTRIC POWERED pumps, grinders and lift stations all over the island. Every one of them have been now destroyed by seawater. They won't power on — or they potentially become fire hazards when the power to the island is restored. Shorting out or simply freezing up from sandy, dirty, turbulent seawater infiltrating each pump, grinder and lift station.

Now what happens?

If is highly logical that the EU will not be able to restore these systems in a timely manner. They are too small, inexperienced and lack any practical knowledge of dealing with a complete shut-down of the sewer system. This means we won't be able to return to our homes for potentially for many months — or possibly over a year.

Where do we go? Our home on the island is our residence — not a seasonal property. After both Helene and Milton we were back in our home in under two weeks. With Helene, it was a matter of days. FPL had power restored in both instances fairly quick. Our septic system was 100% operational. We even had it inspected after Milton and it required NO repairs or service. Keep in mind, even when the power was off, our septic system still functioned.

This won't be the case with the EU's proposed system. The entire sewer system will be shut down. All the electric motors will be destroyed and they won't be fixable. They will require replacement.

How long will this take? How much will it cost? WHO will pay for? I'm assuming that the EU will simply bill every homeowner all over again for replacing the motors and pumps at each home.

The people who live on these barrier islands are extremely resilient. We don't shy away from hard work or fixing our properties. But we DON'T own a money printing press. We can not sustain paying the EU for every aspect of their business — and that is precisely what the EU is demanding each homeowner does — pays them for every expense. It's just not feasible for this to be a successful plan. It will crush us financially and emotionally.

And I also ask you — what happens to a homeowner when they can't pay for all of this? Get a loan? That's not a plan. If you can't afford it, getting a loan is akin to just plugging a few holes in a sinking ship — it just takes a bit longer to sink. I assume many people will be FORCED to sell their homes and likely at a huge loss. It just seems there should be no way a "private for profit" company and our local and state government should be able to force us from our homes. They get rich, we get poor.

Please let us breathe after dealing with two horrific back-to-back storms. I can't imaging how devastating this will be to our islands, and the people who live here, if it gets approved.

Dear Commissioners,

After reading the staff's recommendation to approve EU's sewer application, I am in complete shock. Were they at the same hearings I attended in January?

Did they not remember the laughter when EU's engineer, Jonathan Cole, made it abundantly clear he had no real understanding of what this project would entail on our islands? He claimed, "It's the same cost to put one pipe on the ferry as a thousand pipes," and stated, "I don't know of any tidal impact to a construction project down there." How could he not know? If his numbers are being used by EU's financial expert, Deborah Swain, to estimate costs, shouldn't he have at least a basic understanding of how the ferry operates, the inevitable building delays, or even the type of roads we have?

Let me paint a real picture: it cost over \$150,000 in barge fees alone to build my modest 1,800 sq. ft. home just two years ago. Cole's estimate of \$600,000 for all barge fees is laughable. Plus, when tides are low or winds are high, large trucks can't cross. Just this past January, we went three weeks without trash pickup because Waste Management's smallest truck couldn't make it over.

When asked about potential delays, Cole dismissed concerns, saying there's only a "short line in the morning" and that we have "sand roads or whatever they have out there." This made it crystal clear—he has **never even been here**. In reality, contractors face an hour-long wait to get onto Palm Island each morning, and it's even longer at quitting time. This project would make that situation far worse.

Did the staff forget that **hundreds of islanders** showed up to oppose this sewer project? We shared real, lived experiences—many of us lost nearly everything in recent storms, but the one thing that remained intact was our septic systems. Jack Boyer claimed he walked the islands and saw "septic tanks popped up everywhere." That is simply false and quite honestly absurd. I was here just days after both storms and did not see a single tank "popped up." A few tanks on the beach had lost their lids and filled with sand. **Perhaps instead of forcing a central sewer system on us, we should be discussing ways to better secure septic lids.** 

Did they notice that only a handful of people supported this project? I personally handed out opposition stickers—remember the red circles with a line through them? Out of 500 printed, I came home with less than 100. Fewer than 15 people refused a sticker. The number of speakers in favor? Less than 10, and nearly all of them were either not stakeholders in this application at all or they are directly related to the applicant—his son-in-law, daughter, and wife, who stand to profit from this project. These same family members tried to mislead the room with absurd claims of "turds floating around" (which we all know is nonsense), or gave tearful speeches about their children—only to be called out and admit they were related to the applicant. Then they sulked out of the building.

### It was a circus!

EU has not done its due diligence.

• They have **not** proven a need for this project.

- They had three years since the last application—did they conduct any water testing? No.
- Do they have any quantifiable data showing storm damage to island septic systems? No.
- Could they have gathered real data from residents? Sure. But did they? No.
- Do they have realistic cost estimates? No.

After listening to these hearings, I wouldn't hire Jack Boyer to mow my lawn—let alone install a private sewer system. The fact that anyone would recommend approving this application is **mind-blowing**.

Here's why we **do not** want this:

- There is no proven need.
- It will cost homeowners tens of thousands of dollars, upfront and out-of-pocket. Do you have \$30,000, \$40,000, or even \$50,000 just lying around? Because I don't.
- **EU** is a private company. They can (and will) charge whatever they want. Our water company already does! Did you know we pay more for water than most people in the U.S.?
- The pump system they propose is one of the worst technical choices available.
- The project will wreak havoc on our island—environmentally, logistically, and financially.
- Each homeowner will bear the burden of pulling permits, installing electrical, plumbing, and backup generators for outages. Have they even factored that into the cost? I doubt it.
- There is no performance bond. If Boyer botches this project (as he has others in the past) or costs spiral out of control, we have zero recourse.

So I ask again---why on earth would staff recommend granting this application?

Were they even listening?

I hope you are.

Members of the Charlotte County PSC:

I am writing to urge you to reject this proposal for a privately-owned central sewer system. I am a property owner on Palm Island and will be directly affected by your decision. I would like to share several reasons why I believe this is a bad idea.

- Firstly, no evidence has been presented demonstrating a need for central sewer. The existing septic tanks are sanitary, environmentally safe, and function perfectly well for their intended purpose. This is the proverbial solution looking for a problem.
- The estimated expenses to homeowners range from outrageous to obscene, depending on whose estimate you believe.
- The proposed central system will replace relatively simple and cheap technology with lift pumps and collection stations that are far more complicated, susceptible to power outages, less reliable in general, and certainly less reliable in times of natural disaster.
- The financing scheme for this boondoggle is outrageous. From what I can see, the homeowners will be funding most of the capital costs to build out the infrastructure for a private company. That company will then charge rates that are easily double the equivalent ones in nearby Rotonda. As the old saying goes, nice work if you can get it.

The cherry on top: participation would be mandatory and enforced by law.

So in summary: an unneeded "service"; exorbitant up-front fees, on-going monthly rates far in excess of reasonable; government-mandated participation; and for the sole benefit of a politically-connected private "investor"? No! Absolutely not!

Regarding EU"s application for sewer service for Don Pedro, Knight, and Little Gasparilla Island,

### I AM AGAINST APPROVAL OF THIS APPLICATION AND REQUEST YOU DENY THE APPLICATION!

Being a former CPA involved, evaluated, and testified in regulated Industries rate cases before the ICC (Federal Dept. of Transportation) and the State of Colorado PUC [before deregulation], I understand the legality issues reviewed by the Staff in their suggested approval of this application. Yes, according to the basic 'PSC Rules', Staff considers Environmental Utilities (EU) has met the minimum requirements. Legality issues are one thing, but other items need to evaluated before voting. The island residents from all 3 islands, were heard loud and clear that this is wrong for the islands, not necessary, and only a 'money grab' by EU and it's owners.

However, these PSC rules (including minimums) have many weaknesses like - to prove a need for sewer, "you only need ONE resident requesting service", and there is no restriction on who that person can be, including the applicant – or developer who owns and wants to develop multiple lots on Little Gasparilla and is funding three quarters of the construction for EU. Other apparent weaknesses are (1) the use of estimated costs, most of which are significantly understated, (2) the type of the system, which Charlotte County now is against this type of waste water system because of the excessive costs involved in maintenance, and (3) the design of this system which includes a 10 inch main ending at the gates of the Resort, etc.

These issues all came up in the hearings held in Englewood. Thank you for making it easy for the Islands stakeholders to voice their opinions.

To discuss these issues in more depth the need of service is beyond the reality of common sense. There have been no tests of the water quality by the applicant at all, or maybe they have tested and the water results were good so they could not bring up in the application. Cape Haze basin is known for clean water as testified to by several expert witnesses in the hearings. Charlotte County's continuing water testing has shown no significant water quality issues around our islands (maps posted on their website showing the test sites and results). If there is NOT a problem, why offer a costly, inefficient solution.

### MAKE SURE A PROBLEM EXISTS FIRST, THEN EVALUATE SOLUTIONS.

You heard repeatedly from island residents that even after Hurricanes Helene and Milton, which was 4.6 feet deep under my house, 'septic systems worked fine and there was no spillage or contamination'. To be sure about mine, I had SOS Septic come out and inspect my septic and remove the sludge (as it had been 4 years since I last removed sludge). Why is the PSC need for service level so low that only the applicant needs to say "I request sewer at my residence" to prove a need.

Another wrong against the island residents was the Charlotte County Commissioners unanimous support of this application. In testimony, you heard that the opposing Counsel sent a political based email with an attached resolution draft to the Charlotte County Commissioners and asked it be approved. It was placed on the agenda exactly as counsel drafted it and It was approved, but there was no review by any Charlotte County Staff or departments, only resolution approval. In addition, if you remember, NO Charlotte County Commissioners or staff or department heads came to the hearings, testified, or even sent a communication explaining why they voted as they did. I feel their support for this application was merely a political favor and did not have any meaningful evaluation or discussion. In as much it should be discounted significantly in your vote to approve or disapprove this application

The estimated costs in item (1) above are ridiculous. Too many residents discussed the additional cost and time involved in the having to use the ferry access. EU's expert construction witness claims a minor amount for the ferry and justified it NOT BY the number of trips and cost per trip, not by having to use a private ferry to move equipment on and off Little Gasparilla [no access from Don Pedro Island because of the state park and the 'Beach to Bay' community HOA not allowing equipment move across their private community roads], not by taking into account the morning one hour+ average wait time to get on the island and the afternoon 1 hour+ average wait time to get off. Many residents testified about the real cost of the ferry in fees as well as lost time. The cost to build on Don Pedro and Knight Islands carries approximately a 40% - 50% excess as compared to the mainland. The costs used were mildly updated from the denied application 2 years ago and in the last year and a half the US has seen significant inflation. Hard to understand how these costs did not increase accordingly. The Trump administration tariffs will also add a new layer of cost on top of the inflation. Maybe you should consider approval of this application subject to a rate base cost limit equal to 5% +/- variance from the estimated costs in the application. Put the pressure on EU to build and operate efficiently instead of an open checkbook to build and operate as they want .... With the residents paying the continuing bill. This would also force EU to reevaluate the costs in the application and be more realistic in the related costs in this application – they are not even close to reality.

The type of system is wrong for our islands. This gravity flow type system is always full of waste water slowly moving off the island, now updated with two crossings of the Intracoastal waterway instead of only one. In the case of a power outage there is a potential of a major contamination spill and a backup at each island home. As Charlotte County has stated many times, they will no longer approve or implement this type of system on the mainland because of excessive maintenance costs and potential contamination spills. They suggest a more appropriate vacuum system which whisks the waste off the island rapidly, not allowing it to be hanging in the lines. The vacuum system has been used successfully in the Keys and various other barrier islands.

The design of this system includes a 10 inch main that dead ends at the gates to the Resort. It is common knowledge that the Resort has a cracked septic storage unit and can only safely hold about 50% of their capacity. The cost to repair this holding tank is significant. This 10 in main is paid for by the residents other than the Resort [Knight Island Utilities (KIU) a non-profit utility]. In testimony EU stated that once approved by the PSC, they would approach Knight Island Utilities about buying them out or letting them use the 10 inch main to remove their waste off island. This is not discussed in the application and has a significant cost to the proposed system users, yet the residents get no reduction in calculation of the base rate, etc., only the actual costs to overbuild. There are no bulk rates offered by EU in their rates, so they should not be able to offer a bulk use agreement. Again, this is all planned to put the Resort's cost of waste removal on the non-Resort residents back. Unfair costs and unfair rates. There is also the fact that residents on Lemon Bay Lane are currently hooked up to KIU, but are not in the service area of KIU. They are in the service area of EU, so they will have to pay a hookup fee to EU even though they have already paid one to KIU.

In reality, this application is NOT IN THE BEST INTEREST OF THE ISLANDS.

The testimony by EU that there was raw waste laying on the beach and the septic tanks standing around was limited to Little Gasparilla Island and I suggest it was not that bad or the State of Florida Environmental agency would have been out there testing and shutting down the island because of contamination. Statements like this a absurd and have not documented support. None of these supposedly described situations existed on Don Pedro or Knight Island as testified to by many residents.

In closing, I would remind you that you denied the prior application because of lack of support from Charlotte County and opposition by a significant population of residents. EU did get a support referendum from Charlotte County Commissioners, which should carry only limited weight in your decision because it was merely political motivated and not properly evaluated or discussed by the County, as well as the fact that no one from the County testified or even showed up at your hearings – in support. Hard to say they support it when they do nothing but a vote. On the other hand, when Island residents form action committees and non-profits to fight this application it should be apparent that it is not a few vocal residents against it, but the majority of residents in the service area. Little Gasparilla came with a majority of residents against this proposal. Palm Island Estates HOA (PIE) has fought against the prior sewer applications, and will continue to fight against this "re-filed" application with a majority of the island residents each time willing to donate money for lawyers and testify in front of the PSC.

Remind yourself of the crowd that showed up at the hearings against this application and all the information they gave you about the applicant and the other problems with approval of this application.

# Updating docket number

# Dear Commissioner Clark,

I am writing as a home owner on Little Gasparilla Island to voice my strongest possible opposition to the above docket for a sewer system on the Bocilla barrier Islands. There is absolutely no need for this system as no problem exists with the current management of sewage on these islands and the overwhelming majority of homeowners oppose it. In the words of President Reagan, "If it ain't broke, don't fix it". This proposal is a money making scheme for the FOR PROFIT Environmental Utilities who have NO experience with such a system. The costs would be passed on to us owners and is estimated to cost each home owners in excess of \$40,000, plus monthly fees once in place. They are proposing an outdated low pressure technology that Charlotte County won't install any more because of the excessive cost to maintain. These have a high failure rate and spillage of raw sewage into our delicate island and intracoastal environment will be disastrous for wildlife, the fisheries and tourism. Construction fo this system will be very disruptive to the island residents. These are bridgeless islands and access is dependent on a ferry which does not operate on a regular schedule. We strongly oppose Docket #20240032-SU, a proposal for a privately owned, for-profit utility that is unnecessary, financially exploitative, and environmentally reckless. As residents who spoke out against this proposal at the public hearing, we demand that the Florida Public Service Commission reject this application for the following reasons:

- 1. No Justification for Service The overwhelming majority of island residents do not want or need this service. This proposal is a Trojan horse for unwanted commercialization that will erode the very character of our island. We purchased our property in 2021 for its undeveloped "Old Florida" charm. It would be a disgrace to sacrifice that to developers' profits.
- 2. Unacceptable Financial Burden Private utility services impose exorbitant costs on residents, far beyond what a county-run system would require. Forcing homeowners to pay for an unnecessary system is outrageous, especially when the community overwhelmingly opposes it.
- 3. For-Profit Exploitation vs. Public Accountability Unlike a county-run system, this private entity is designed to maximize profits at homeowners' expense. County projects allow residents to spread costs over time; this does not. Many of us are still recovering from Hurricanes Ian (2022), Helene (2024), and Milton (2024). Forcing immediate, steep financial obligations on us is unjustifiable. We are already burdened with costly property repairs that are not covered under insurance (100% of these repairs are out of pocket)
- 4. Outdated and Inefficient Technology The proposed system fails to incorporate modern, sustainable infrastructure. Outdated methods will result in breakdowns, inefficiency, and increased environmental risks. This condemns us to the very problem they are claiming to fix. - 5. **Severe Environmental Consequences** The proposed construction and operations will disrupt wetlands, harm wildlife, and threaten an already delicate water quality. This is reckless and unacceptable.
- 6. Intolerable Traffic Disruptions Our island has only one way on and off: the ferry service operated by Palm Island Transit. Construction-related traffic already causes delays exceeding an hour. I recently experienced this firsthand due to ongoing hurricane repair work. Adding unnecessary infrastructure projects will create intolerable congestion and negatively impact residents' quality of life.

- 7. Maintenance and Emergency Failures The plan requires grinder pumps at each home, which will corrode in our salt-air environment. What happens when one fails at night or a holiday or weekend, or when the ferry is not operating? How will homeowners address emergencies when private ownership means slower response times?
- 8. Power Outages and Operational Risks Frequent power outages already plague our area. A low-pressure sewer system requires electricity—how are we expected to use basic sanitation if the power goes out? Will we now be forced to install generators? Will every lift station have one? These critical concerns have not been addressed.
- 9. Violation of Property Rights This proposal mandates a 15-foot easement on private property. That is an egregious overreach. Our property is not large, and losing 15 feet is absolutely unacceptable. This is an infringement on private landowners' rights.
- 10. Unwanted Commercial Development This sewer project is a clear setup for commercial expansion, increased urban sprawl, and destruction of our community's unique character. We demand transparency: Who is pushing this project, and who stands to gain financially? This proposal is not in the best interest of residents—it is a play for profit at our expense.
- 11. **Zero Public Oversight** A privately owned utility means zero transparency. Residents will have no recourse when rates skyrocket, service fails, or maintenance is neglected. Publicly managed utilities ensure accountability—this for-profit scheme does not.

This proposal is an unmitigated disaster for homeowners, the environment, and the integrity of our community. We urge the Florida Public Service Commission to reject Docket #20240032-SU immediately.

- 1. We (island residents) have a private ferry service that is the only means of accessing our island. The costs for this service is very expensive. Although it does not apply to this docket, it is an example of where private companies, providing a service to the island becomes abhorrently expensive.
- 2. There is no need for service as there has been no water testing directly around our island showing any problem. Their testing was from the other side of the state. I am the owner of the house at 31 Bayshore Circle on Palm Island, Placida, FL 33946.

I am also a mechanical engineer who worked for BMW for several decades. As head of the Product Analysis department my task was to evaluate the field performance of state of the art safety technology.

This letter is to express my grave concerns about the sewer system proposed by Environmental Utilities, LLC (EU). The Low Pressure Sewer System EU is trying to get permitted is proven to be susceptible to failure.

A low-pressure sewer system (LPSS) has some downsides compared to gravity or vacuum sewer systems. Here are a few reasons why it has to be considered problematic:

- 1. **Dependency on Pumps** LPSS relies on grinder pumps at each property to move wastewater. If these pumps fail or lose power, sewage can back up into homes or cause overflows.
- 2. **Higher Maintenance Costs** Each home or business must maintain its own pump, leading to increased repair and replacement costs over time. Municipalities also face ongoing maintenance issues.
- 3. **Vulnerability to Power Outages** Unlike gravity sewers, LPSS requires electricity to function. During storms or grid failures, the system can stop working, leading to service disruptions.
- 4. **Shorter Lifespan of Equipment** Grinder pumps and pressure pipes have a shorter lifespan than traditional gravity sewer components, leading to more frequent replacements and repairs.
- 5. **Potential for Clogs and Failures** Pumps can become clogged with debris, grease, or improper materials (like wipes), requiring expensive servicing.
- 6. **Higher Long-Term Costs** While LPSS can have a lower initial installation cost in certain areas, the long-term maintenance, replacement, and operational expenses often make it more expensive over time.

There are counties which actually replace those type of system, i.e. Ruskin County where they replace the Low Pressure Sewer System for a more reliable Vacuum Sewer System.

"This project will also replace the existing low-pressure sewer systems in the project area with more reliable sewer service. The existing systems are aging and becoming more susceptible to failures, are increasingly expensive to maintain, and are unreliable during power outages."

We are writing you once again to voice our concerns about putting a private sewer system on our barrier islands.

- 1. We already have a private ferry service that is the only means of accessing our island. The costs for this service is very expensive. Although it does not apply to this docket, it is an example of where private companies, providing a service to the island becomes abhorrently expensive.
- 2. There is no need for service as there has been no water testing directly around our island showing any problem. Their testing was from the other side of the state. Also, each community meeting and PSC meeting was met with community backlash and petition to stop this process from costing the local taxpayers AGAIN to fight this scheme.
- 3. The system will cost my household \$40,000 to install. On top of that I ALREADY HAVE this system that failed in the hurricanes, at my home. It is an INFERIOR solution.
- 4. No competition, no opt-out provision, (if you already have one), and no structured payment plans. Their position is pay up or leave.
- 5. I have a system very similar to the one being proposed and it is BAD, expensive to maintain, and fails with flood events. Overflooding is the thing that they say is the reason to have them installed. SIMPLY, it wont work. Other communities have REMOVED this system in our county because it is outdated.
- 6. The impact on our fragile ecosystem on the islands would be horrendous.
- 7. Our island does not have a traffic system that will support such an invasive installation process.
- 8. There is no way for service to be performed on these systems from 10:30 PM to 6:30 AM. (Ferry hours)
- 9. Each homeowner will have to provide electric permits and service, plumbing and the system will need a generator to run in a power outage.
- 10. Mandatory easement of 15 feet is being proposed WITHOUT JUST COMPENSATION. It is essentially a taking of property in my view.
- 11. So many other faults with this proposal, NO BONDING REQUIREMENT, the company has never run one of these expensive systems and will just pass the increased costs onto the island homeowners. There is little if any oversight.

I am writing to express my strong opposition to EU's proposed central sewer system for our island community. This project is not only unnecessary but also financially burdensome, environmentally destructive, and technologically flawed. I urge you to deny EU's proposal for the following reasons:

- 1. No Demonstrated Need There has been no water quality testing or scientific evidence presented to justify the need for a sewer system. Implementing such a drastic and costly project without clear justification is irresponsible. Additionally, the overwhelming majority of folks that spoke at the January service hearings were strongly opposed (with the exception of those that had financial interest or were related to the applicant), yet this proposal is being pushed forward without our consent. - **3.** Use of Outdated Technology EU plans to install a low-pressure sewer system—an outdated technology that Charlotte County itself no longer installs due to excessive maintenance requirements. It is unreasonable to saddle our community with an inferior system that even the county has deemed unfit. Is it not a red flag that the EU is suggesting equipment that Charlotte County considered unsuitable?
- **4. Environmental Destruction** The construction process will cause years of disruption and irreversibly damage our island's fragile ecosystem. Natural wildlife habitats will be destroyed, and the character of our island will be permanently altered. The environmental cost of this project is far too great. *Is it worth destroying the environment and essentially extorting millions of dollars from island residents to stuff the pockets of the inexperienced EU?*

I hope this letter finds you well. I am writing to express my concerns regarding the proposed central sewer system project for Don Pedro Island, Knight Island, and Little Gasparilla Island. As a resident of this community, I strongly believe that the project, as currently proposed, is not in the best interest of our environment, economy, and the well-being of our residents. Therefore, I respectfully urge you and your colleagues to please decline the proposed implementation of the central sewer system.

Furthermore, the central sewer system may not be necessary for our community at this time, as residents currently use private septic systems that function adequately. The proposed system would essentially require significant investments in infrastructure where it will not provide enough tangible benefits to justify the costs.

# 3. Disruption to the Community

The construction of a central sewer system would create significant disruptions to daily life. Roads may need to be torn up, the ferry lines will be outrageous and daily activities will be significantly impacted.

Additionally, the project could result in a loss of property value as residents face the inconvenience of construction and potential changes to the character of our special and fragile island. This could lead to discontent among property owners, as well as an overall decline in the quality of life for those who live here.

# 4. Lack of Community Consensus

The lack of widespread community consensus about this initiative is troubling, and it is essential that local residents are consulted and engaged before making a decision that will impact their lives for decades to come. Majority of residents are not convinced that this is the best course of action, and without their full support, the project may only foster division within the community.

<u>Issue 3:</u> Is Environmental Utilities, LLC's application consistent with Charlotte County's Comprehensive Plan and/or Sewer Master Plan?

<u>Recommendation</u>: EU's application does not appear to be consistent with the County's Comprehensive Plan but does appear to be consistent with the Sewer Master Plan. However, the County's Resolution establishes support for EU's application, and the Commission is not bound by Charlotte County's Comp Plan or Sewer Master Plan.

<u>Issue 4:</u> Will the certification of Environmental Utilities, LLC result in the creation of a utility which will be in competition with or duplication of any other system?

**Recommendation:** No. There are no other wastewater service providers in or near the area who are willing or able to provide wastewater service to the proposed service territory.

<u>Issue 5:</u> Does Environmental Utilities, LLC have the financial ability to serve the requested territory?

**Recommendation:** Yes, the Utility has the financial ability to serve the requested territory.

<u>Issue 6:</u> Does Environmental Utilities, LLC have the technical ability to serve the requested territory?

**Recommendation:** Yes, EU demonstrated that, with the retention of outside professionals for the construction and operations of its system, it has the technical ability to serve the requested territory.

<u>Issue 7:</u> Will Environmental Utilities, LLC have sufficient plant capacity to serve the requested territory?

Recommendation: Yes. The Bulk Sewer Treatment Agreement (Agreement) with Charlotte County reserves adequate capacity to serve the proposed service territory and demonstrates that EU has planned for the estimated needs of the proposed service area.

**Issue 8:** Has Environmental Utilities, LLC provided evidence that it has continued use of the land upon which the utility treatment facilities are or will be located?

Recommendation: Wastewater treatment will occur pursuant to a Bulk Service Agreement. As such, the Utility does not own or operate the treatment facilities and evidence of continued use of the land is not required or applicable in this instance.

<u>Issue 9:</u> Is it in the public interest for Environmental Utilities, LLC to be granted a wastewater certificate for the territory proposed in its application?

**Recommendation:** Yes. Based on the recommendations in Issues 1 through 8, it is in the public interest to grant the Utility Certificate No. 585-S to provide wastewater service to the territory described in Attachment A.

**Issue 10:** What is the appropriate return on equity for Environmental Utilities, LLC? **Recommendation:** The appropriate return on equity (ROE) is 8.66 percent with a range of plus or minus 100 basis points.

<u>Issue 11:</u> What are the appropriate rates and rate structures for Environmental Utilities, LLC?

Recommendation: Staff's recommended wastewater rates, shown on Schedule No. 4, should be approved. The Utility's proposal to include a repression adjustment should be denied; therefore, the staff-recommended rates shown on Schedule No. 4 do not include a repression adjustment. The rates should be effective for services rendered or connections made on or after the stamped approval date on the tariff sheets, pursuant to Rule 25-30.475, F.A.C. The Utility should be required to charge the approved rates until authorized to change them by the Commission in a subsequent proceeding.

<u>Issue 12:</u> What are the appropriate initial customer deposits for Environmental Utilities,

Recommendation: The appropriate initial customer deposit is \$318 for wastewater for the residential 5/8 inch x 3/4 inch meter size. The initial customer deposits for all other residential meter sizes and all general service meter sizes should be two times the average estimated bill. The approved customer deposits should be effective for connections made on or after the stamped approval date on the tariff sheets pursuant to Rule 25-30.475, F.A.C. The Utility should be required to collect the approved initial customer deposits until authorized to change them by the Commission in a subsequent proceeding.

<u>Issue 13:</u> What are the appropriate miscellaneous service charges for Environmental Utilities, LLC?

Recommendation: The appropriate miscellaneous service charges are shown on Schedule No. 5 and should be approved. The Utility should file revised tariff sheets and a proposed customer notice to reflect the Commission-approved charges. The approved charges should be effective for services rendered on or after the stamped approval date on the tariff sheet provided customers have received notice pursuant to Rule 25-30.475(1), F.A.C. The Utility should provide proof of noticing within 10 days of rendering the approved notice.

<u>Issue 14:</u> What are the appropriate service availability charges for Environmental Utilities, LLC?

Recommendation: The appropriate service availability charges are shown on Schedule No. 5 and should be approved. In addition, the Utility's proposed service availability policy should be approved. The approved charges and policy should be effective for connections made on or after the stamped approval date on the tariff sheets pursuant to Rule 25-30.475, F.A.C. EU should be required to collect its approved service availability charges until authorized to change them by the Commission in a subsequent proceeding.

I am writing one more time to implore you to please deny the application by Environmental Utilities to install sewer service to the bridgeless barrier islands in Charlotte County.

We do not want, nor do we need these sewer services. The fact that a couple of developers who do not live on the island and the friends and family of the owners of Environmental Utilities want this sewer is not representative of the vast majority of island residents who are adamantly opposed to it. We have been shown no proof at all that our septic tanks are causing any kind of environmental problem in the area, and we are happy with our current system. Our current systems work when we have power outages, which are more and more common and last much longer than power outages on the mainland. We need to be able to use our sewer systems during these power outages.

The cost that Environmental Utilities estimates is ridiculously low for any type of construction on the island and shows that they do not understand the limits that arise when it comes to getting materials and labor onto the island. Furthermore, we have no control at all over what these costs end up being and Environmental Utilities has no reason to try to minimize these costs for us as none of the costs are being borne by them even though all of the profits will be recognized by them. This is an unnecessary cost to us homeowners, both in the construction and in the ongoing monthly fees where we currently do not have any.

Our islands are suffering from four hurricanes in three years. Traffic is already drastically increased due to the large number of contractors that are required while we try desperately to rebuild our community. The last thing we need or have the bandwidth to deal with is another huge capital expenditure and another full crew of workers and trucks trying to get on and off of the island every day. Our community, our wildlife, and our infrastructure (except for our septic systems, which are overwhelmingly okay after these storms) have been decimated and we are struggling to get back to some sense of normalcy. Please do not make this harder, more expensive, and take longer than it already is going to.

My husband Jim and I are homeowners on Don Pedro Island.

I began the first draft of this email while sitting in line on the mainland waiting for the ferry to take me back to the island after a Dr. appointment. I have been waiting for an hour and will probably wait another 45 minutes or so. You see, because of the construction equipment needed to repair homes on the island as a result of the past 2 hurricanes, the line for the ferry is very long. If I have to leave the island starting at 3:00 or so, I need to plan on the same length of waiting time. I am not complaining. My neighbors and I must get these repairs done and that takes people and equipment. This is the reality of living on an island that requires a ferry to transport the cars. Why am I sharing this? I want you to get a sense of what life is like on our island. Why we choose to live here. I cannot even imagine the traffic that would be caused by the equipment needed for installation of a sewer system. But this is secondary to the facts of the issue at hand.

I am frankly shocked that the staff report to the PSC is recommended granting the certification to Environmental Utilities for central sewer. I was one of the 200+ island residents who spoke recently in opposition of the EU's application for Central Sewer. I based my opposition on facts. I am truly suspicious of how fair and balanced evaluation of the facts of this case has been arrived upon by the staff of the PSC.

Fact: EU has NO experience building a central sewer system.

>Would you hire someone to do a major renovation for your home, for example, with NO home renovation experience?

Fact: The community residents have never been polled to find if there is support for a central sewer system for our island.

>Over 200 people came out to speak against the proposal in January. Why is the overwhelming opposition being ignored?

Fact: The estimated cost to the homeowner is over \$40,000 with NO pay-over-time option, NO low interest loans and NO WAY to opt out.

>Could you afford a \$40,000 expenses like that? MANY people on our island can not.

Fact: EU is a private, for-profit company. There is no competition to help keep costs down and no central oversight.

>Again, would you hire someone for your home renovation without getting multiple bids and an agreed upon contract of the cost? Would it be fair for you to be told mid project that it was going to cost more?

Fact: EU plans to install outdated technology that requires excessive maintenance. Even Charlotte County won't install this type of low pressure system anymore.

< Outdated technology??

Fact: There has been no water testing evidence to show the need for sewer service. <: No demonstrated need!

#### Questions I have:

? I am wondering if any of you have visited our island that you are making this ruling on? It is unique, quiet, and full of nature where you see gopher tortoises crossing the unpaved roads on a warm day. These gopher tortoise burrows are found all over the island. There are very specific rules surrounding relocating these burrough when a new homeowner wants to build. I am unclear how EU would be able to relocate all of the potentially affected boroughs. The facts about the gopher tortoise, a **threatened species**, protection and relocation can be found at <a href="https://myfwc.gov">https://myfwc.gov</a>.

? I am trying to understand how the grinder pumps used in the proposed low pressure systems that are susceptible to the salt air would work effectively. From what I understand, if there is a power outage or need for maintenance, the waste does not move away from our homes. How does EU plan to keep over 700 homes' systems working smoothly during power outages? Even after 3 major hurricanes, our septic systems are working fine. How long would it take EU to get us all 700 homes up to speed? So in the meantime, what happens to the waste? I can picture the family next door, who is renting a home on our island for their spring break, losing power after a simple thunderstorm. What do those people do for toilet use?

? What do we do as residents if EU runs into unforeseen problems that are bound to show up during this MAJOR project? I envision torn up roads, heavy equipment all over the island standing and waiting for a solution. Because there is no performance bond that would allow homeowners to have a single point of recourse in the event of cost overruns or project failure. Can I call your office and have you help me out in the event of this happening?

I am sure you can hear my passionate opposition to this project. I could continue with many more of my concerns based on the facts, but I will conclude with a plea to deny the proposed Environmental Utilities project.

As a property owner of a house on the Gulf and on a canal on Palm Island (Don Pedro Island) I am writing, pleading and begging for you **not to approve** the above application certificate for Sewer from Environmental Utilities.

At the hearings, many people who would be affected by the mandated sewer spoke how it was very clear that given that there is **no need** to change from our current septic systems. The few that spoke in favor of the sewer were **relatives** (daughters & in-laws), business partners and close friends of Jack Boyer (they all got together on breaks). Reasons not to change from our current septic systems include:

- 1. There is no need to eliminate our septic systems they are in great working order and many testified that were no sewage compromises from the two hurricanes (Helene and Milton) wash overs (unlike Boca Grande who had sewage due to their sewer system being damaged). Many counties on the west coast of Florida experienced sewage compromises with their sewers. We did not with our septic systems!
- 2. Two engineers spoke how Jack Boyer went over EU's plan for a pump system (to have them work for them) a couple of years ago and they recommended against using a pump system (if a sewer system was necessary which they felt was not necessary). They said that was something Jack Boyer was not interested in hearing and stopped contacting them.
- 3. Given the two hurricane wash overs Palm Island experienced in 2024, a pump sewer system would be a disaster since (based on how pool equipment was ruined) every pump would have to be replaced. This would mean houses would not have waste capabilities for probably many months as hundreds of homes would need new pumps. That would be a disaster for people to be able to begin the cleanup process and do what is necessary to prevent mold (mold is not covered by flood insurance). A pump sewer system would be grossly inappropriate for Palm Island.
- 4. **If a sewer system was necessary,** we sure would not want a Limited Liability Corporation who has little to no sewer experience being in charge of it. According to Environmental Utilites Annual Report filed with the Florida Department of Corporations, Jack Boyer is the ONLY listed officer. They are not a true

experienced company with any depth. We would want the local government to be responsible and assume responsibility so that the users are protected for years to come.

5. The cost to implement something that is not needed (I have heard anywhere from \$20,000 to \$50,000) for each property owner is going to hurt everyone - especially since every property owner has already suffered ten of thousands of dollars worth of damage from hurricanes Helen and Milton. This is in addition to the increasing Real Estate, operational and Insurance costs Again, this is not needed and will financially benefit a few people in a big way.

I disagree with the following issues in the summary of this Case that is covered in the Agenda for Commission Conference:

Issue 2 - there is no need for hundreds of home owners on the Islands to replace their working septic systems. I believe this is generated by the Palm Island Resort - north end of Palm Island who wants to update their wastewater system with a sewer system and have the expense to do so shared with hundreds of owners (who do not need or want such a system). The owner of the Resort and Mr. Boyer are working closely with this project as are some of the Charlotte County Commissioners (none showed up to the local hearings). Follow the money.

I would ask that if the Resort and "developers" want it, then let them pay for it and have it available to them and **NOT MAKE IT MANDATORY TO THOSE WHO DO NOT NEED IT**.

Issue 3 - the Charlotte County commission is now "in" for this project (where there was not County support in 2024) since the right people have probably been properly "motivated" to support it.

Issue 5 - Being a Limited Liability Corporation - they can walk away at any time without recourse. They do not have a proven track record for such a project and two engineers testified at the public hearing how Environmental Utilities approach (a pump system in a flood zone) is grossly flawed. Again, the company has no depth (Jack Boyer is the only office) nor experience. If sewer is going to be considered it should be installed and run by the County, not a LLC.

Issue 6 - They have NO track record of implementing a sewer system

Issue 9 - the only public interest for the granting a wastewater certificate is for the Resort, Jack Boyer, the Boyer family, any EU partners and "unknown developers". The hundreds of property owners of Palm Island do not feel it's in our public interest.

My name is Joe Noto and I live at 181 N. Gulf Blvd. #10, Placida, Florida 33946 on Palm Island. <u>I am</u> formally requesting that the PSC deny EU's application for wastewater service, and they be prohibited from applying again and again.

Having heard all the arguments a couple years ago, one <u>of the main reasons the PSC denied this</u> <u>application then was the overwhelming opposition from the community</u>. At the recent public hearing we, the community, again expressed our overwhelming opposition to this project. <u>Nothing has changed</u>. Although the staff of the PSC seems to have assessed the application for completeness and legality, you commissioners still have a chance to do the right thing for the public you serve.

Attached is the 4/10/2024 email I sent you detailing my opposition to this project. Please read it again. I'm certain you've heard this from other islanders, and are aware of the numerous reasons this project should not be approved. Here are a just a couple.

- We do not want a low-pressure system. A low-pressure system is the least desirable sewer system available. Due to high maintenance costs, Charlotte County has stopped using low-pressure systems in new installations unless it is the last possible option.
- We don't want a private for-profit sewer. There are no grants or subsidies, no competitive bidding, no performance bond, no oversight, no single point of recourse.
- The cost is excessive and unreasonable. If the County thinks it'll cost \$30k on the mainland, why would EU think they can do it on a barrier island for less than \$20k? Engineers and expert witnesses estimate the cost of a household sewer hook-up on the island to be \$46,000. And, our monthly will then likely be the highest in the state! The cost to us island residents is excessive and unreasonable and not necessary.

Environmental Risk. According to data from Charlotte County data, low pressure sewer
systems contribute disproportionately to sewer spills. Despite making up only 25% of the
county's sewer systems, they are responsible for over 51% of all reported spills. For this and
other reasons which you are undoubtedly aware of,

In addition, I'm sure you are well aware of the numerous other reasons this project should not be approved. In my opinion it should be relatively easy to conclude this project isn't wanted, isn't needed and simply doesn't make sense. My name is Joe Noto and I live at 181 N. Gulf Blvd. #10, Placida, Florida 33946 on Palm Island. I apologize for the length of this email, but this central sewer / wastewater service project is unnecessary and wrong for so many reasons. And the PUC, having heard all the arguments a couple years ago, did not grant approval of the application. But now we have to go through this costly process again. This is simply not right or fair.

The central sewer system proposed by Environmental Utilities will have a significant negative impact on me, the environment, and our community. As a homeowner in the proposed service area. Lam formally requesting that the PSC deny EU's application for wastewater service, and they be prohibited from applying again if it is denied. We went through this lengthy and costly process once before, and there was ample support and evidence for not approving the EU application. I'm not sure anything has changed; so it's very troublesome that we now have to go through it again. Seems to imply this will never end, and that's simply not right or fair.

Please read my concerns below so that you understand why <u>I strongly oppose the central</u> sewer system proposed by <u>Environmental Utilities</u> (EU).

- 1. I am opposed to the installation of a central sewer by a privately owned, for-profit utility. Charlotte County is abdicating its responsibility to a private operator who has never owned a wastewater utility company before.
- 2. There has been no evidence provided that supports a need for service in the proposed service area. I have not requested, nor do I need this unnecessary system.
- 3. Expert witnesses at the last Administrative Hearing refuted the arguments that EU put forward supporting the need for service.
  - a. Previously, the Final Order released by the PSC on this very matter stated: "noting the level of opposition to EU's proposal by its prospective customers, we find that customers are highly unlikely to voluntarily connect to EU's system."
  - b. As a public official, I would like to think you do things in the best interests of your constituents. This project is certainly not in the best interests of your constituents.
- 4. I cherish our environment, and you should too.

- a. No water quality testing has been done in our area to prove the need for a central sewer system.
- b. This project could very easily have a negative impact on, and interfere with, the habitat of endangered species such as the gopher tortoise.
- c. The risk of a central sewer leak into the intercoastal waterway seems greater than the risk of one or more septic systems developing leaks.
- 5. I am concerned about the ability of Environmental Utilities to financially handle this project, and adequately maintain such a system. I have not been provided any information about the financial history, stability or viability of Environmental Utilities and their management team.
- 6. I am also concerned as to whether Environmental Utilities has the technical expertise and capability to handle such a project.
  - a. To the best of my knowledge, EU is not a contractor that has won a bid to install sewer systems.
  - b. It is my understanding that Environmental Utilities has not provided adequate information on how the system will be serviced in the event of failure during a storm or other adverse conditions.
  - c. What experience do they have with other wastewater systems?
- 7. I am concerned about the costs of this <u>unnecessary and unwanted project</u>. My current system costs about \$20 per month (about \$700 to have my tank pumped every three years) Given what I've seen, it appears the EU system will cost me at least \$350 per month (amortize the \$12,000 initial hook up cost over 10 years, plus monthly service, plus the same periodic pumping) plus unknowns (c, d, e, and f below). Without the unknowns this is a 1,750% (one thousand seven hundred fifty percent) increase. That's ludicrous and irresponsible.
  - a. Initial hook up cost. \$\$\$\$\$\$\$.
  - b. Monthly service costs. \$\$\$\$\$\$\$\$\$
  - c. Cost for a separate electrical panel. \$\$\$\$\$\$\$\$\$
  - d. Cost for a generator to ensure there is no sewage back up during a power outage (which we experience frequently). The system's grinder pump will probably not function long without power. \$\$\$\$\$\$\$\$\$\$\$\$\$
  - e. I am concerned about the life of the equipment installed by Environmental Utilities and their ability to maintain it. This could result in future charges to homeowners because of the needed repair costs. \$\$\$\$\$\$\$\$\$\$\$\$\$\$
  - f. Cost to replace existing (more than "basic") landscaping that will be destroyed digging out my existing septic tank, putting in an EU septic tank, and running sewage lines. \$\$\$\$\$\$\$\$

- g. Cost to have the EU tank pumped out periodically as I currently do. \$\$\$\$\$\$\$. If my existing system is replaced by EU tank, they should be required to pay to have it pumped out. It would be their system.
- h. In summary, this unnecessary and unwanted project will be very costly to me and a lot of other homeowners who live on a fixed income. It will only further burden us, coming at a time when we're dealing with high inflation and soaring costs on top of Hurricane lan repairs.
- 8. Also, it is my understanding that EU wants a utility easement, at no cost to them, that will go through my property from the tank that would be located near my house to the connection to the sewer line near the main road. This is my property, and I should not be forced to grant a free easement for this <u>unnecessary and unwanted project</u>.
- 9. It is my understanding that our island is in the Rural Service Area which supposedly is not designed for commercial / high-density development. It appears this project is designed to encourage and attract commercial / high-density development which is certainly not in the best interest of residents.
- 10. There is, and will continue to be, a lot ferry traffic for the existing level of residents, renters and tourists, along with the construction traffic related to re-building from the hurricane, and new construction. This has made wait lines / times for the ferry unpredictable and ridiculously long. The heavy equipment and materials needed on the island for this project would make this situation even worse for a very long time.

We are owners on Don Pedro Island and I would like to take an opportunity to **oppose** the proposed installation of central sewer on the Island(s). What is being proposed is not something that has proven to be needed, it is extremely expensive to the home owners that have been through so much (and most of us have just spent tens of thousands of dollars to repair existing septics) and the system is extremely inefficient while putting a tremendous amount of financial distress on homeowners. If an actual sewer was being proposed like one would find on the mainland, perhaps it would make sense, but what is being proposed is absolutely not something that is logical.

For instance, the system being proposed requires a generator in case of power outage. Guess what. We have a lot of power outages. We all know how much a generator costs, how hurricanes work and how mechanical/electrical equipment with salt water don't mix. How does one ensure sewage doesn't back up when we have storms? How do we even connect generators when many homes are already maxed on their panels? Is the county going to update and fix our grid, assist with home electrical upgrades? Many homes are built to the extent of the lot, where are these new systems going to be placed and how does it keep the island "Old Florida Charm"? Who is the long term "General Contractor or manager" of this project and the overall watchdog of such a project? The county? EU? Army Corps of Engineers? Have any water quality testing been done to prove that this is a need? Are we going to get a credit or be compensated for easement rights on my property? How do "you" expect people to pay for this unwanted and unvalidated service? The list of fees for basic costs is astronomical, in addition to monthly bills, connection fees, usage, etc, etc.

I was among the group of people that both emailed and spoke of my opposition to this matter. I understand that staff has recommended approval, however there is still tremendous opposition for all the reasons you heard by an energized vocal representation of the actual people affected by this proposal.

I also understand some of the legal constraints under which the PSC operates.

I would suggest staff is incorrect in at least a few of the analyses done.

The financial ability for EU to complete this project is truly insufficient. You heard many people tell you the cost estimates were incorrect and I do not see that any independent effort was made to verify EU's claims in detail. For one example, barge costs alone have been grossly underestimated, as have the impact of labor cost (and response times) due to having to wait for very long periods for barge access to the islands. Truly, all that had to be done was to look into actual barging costs of any of the home being built or repaired now.

You have testimony and documentation that water quality testing done by the state STATE near and around the island themselves are very good and, in some areas, pristine. EU's experts claim that there is bad water and the dying seagrass. While true, this is a very dangerous sleight of hand as the issues brought up by EU are actually located by the perimeters of golf courses, not near the islands, which are watered with reclaimed water from the same county plant the EU will be connecting to. EVERY SINGLE ADDITIONAL HOOKUP TO THIS COUNTY SYSTEM, FROM THE ISLANDS OR NOT, FROM SEPTIC-TO-SEWER EFFORTS OR NEW DEVELOPMENTS, ACTUALLY MAKE THE WATERS EU IS CLAIMING TO PROTECT WORSE AS UNTREATED NITROGENS ARE PUT RIGHT BACK INTO OUR WATERS THRU THE USE OF RECLAIMED WATER. THIS WILL CONTINUE UNTIL THE WATER PLANTS ARE CONVERTED TO ADVANCED WATER TREATMENT PLANTS WHICH IS MORE THAN 10 YEARS IN THE FUTURE. This is so clearly NOT in the public interest and you have the power to go against staff recommendations and do the right things for the public interest of the citizens.

As a resident of Palm Island, I write to register my <u>unqualified opposition</u> to the central sewer project proposed by EU for the following reasons:

- 1. There's no evidence of any kind of need for sewer service and no polling of the community for our opinion.
- 2. Excessive estimated, up-front cost of \$40,000. per household. Without a pay-over-time option and/or low-cost loans, which are not provided by EU's proposal, many of our homeowners cannot afford this.
- 3. Because EU would be a private company running the sewer instead of the county, we won't be afforded payment plans, there's no competition, and no central oversight.

#### **Dear Commissioners**

I am writing to express my strong opposition to the proposed public sewer installation on Knight Palm Island. I am a resident of this island and have serious concerns about the project, its necessity, and its potential negative impacts on our community and environment.

My opposition is rooted in the following critical issues:

#### • No Need for Service:

- There has been no comprehensive water testing or evidence presented that demonstrates a genuine need for a public sewer system.
- o Crucially, there has been no community-wide polling to gauge resident interest or support for this project.

#### Excessive Cost:

- o The projected homeowner cost of over \$40,000 upfront is exorbitant and financially burdensome.
- The absence of payment plans, low-cost loans, and an opt-out option creates an unfair and unsustainable financial imposition on residents.

#### • Private & For-Profit Operation:

- o The involvement of a private, for-profit entity (EU) eliminates the benefits of county oversight, such as payment plans and competitive pricing.
- o This lack of oversight leaves residents vulnerable to potential cost overruns and service issues.

## Outdated Technology:

o The proposed low-pressure system is considered outdated and requires excessive maintenance, as evidenced by Charlotte County's discontinuation of its use.

## • Damage to the Environment:

- The construction will cause significant disruption and long-term damage to our island's delicate natural wildlife habitats.
- o The islands natural beauty will be damaged for decades.

## • Traffic Congestion:

o The increased construction traffic, compounded by existing ferry delays and island accessibility challenges, will exacerbate traffic congestion and inconvenience residents.

#### • Maintenance & Emergency Situations:

- o The required individual grinder pumps are vulnerable to our harsh salt air environment.
- o Emergency repairs after ferry hours pose significant logistical challenges.

## • Undue Installation Burden to the Homeowner:

o Homeowners will be responsible for obtaining electric permits, providing electrical service, plumbing, and installing generators for power outages, adding significant cost and complexity.

## Mandatory Easements:

o The mandatory easements, requiring approximately 15 feet of property from the house to the road, will restrict homeowners' property use and development.

## • Undesirable Development:

o The installation of a central sewer system opens the door to high-density development, such as high-rises, which would fundamentally alter the character of our island, as seen on other barrier islands.

## • No Oversight:

o There is no performance bond required, and no single point of recourse in the event of cost overruns or project failure. This leaves the home owners with all of the risk.

I urge you to reconsider this project based on the significant concerns outlined above. The financial, environmental, and logistical challenges far outweigh any perceived benefits. I believe that preserving the unique character and natural beauty of Knight Island is paramount.

As you know, this will be the second time the PSC has ruled on this. The previous denial was based on no county support and the demonstrated lack of desire to have sewers by the community.

We are quite sure that individual contact by EU and their lawyers was the reason for the county reversed their support.

If the county wants us to have sewers, they should study the type of sewer appropriate for our island. Then put it out for bid. Then get us grants if appropriate. If grants are not available, then require us to pay over some years in our taxes. This is how most local governments process the sewer implementation, if needed.

How our need, according to Charlotte County, could change in only 2 years is not understandable unless they did a study and demonstrated that need.
