Hi,

Those of us who suffer multiple power interruptions during storms and at other times we appreciate the response.

We believe your data does not include lightning strikes and high wind events initiating the replacement of old poles and lines. This has happened in both Terra Mar and Bel Air in the last 2 years without the impact of major named storms. Of course the data also does not include the multiple brown outs we have each experienced because of inadequate trimming by the residents and/or FPL.

Approximately 20 years ago LBTS annexed 2 unincorporated 1 family residential neighborhoods Terra Mar and Bel Air which currently comprise our most neighborhood vulnerable areas. These 2 have extremely aged and vulnerable overheads lines distributing power. The neighborhoods are also surrounded by the Ocean and Intercostal .

Indeed we know bad weather plays no favorites and we need the underground installations for maximum protection as was originally intended by the enabling program assigned to FPSC to protect the public and not FPL which has a not governmental roll in the execution of public policy.

The selection process is inherently biased against the most vulnerable neighborhoods by the collection of the certain data selected by FPL.

We need the intervention now so that in the 2 to 3 years it takes for installation when we can begin to be protected.

Good afternoon, Commissioner Graziano,

I am following up in response to your email to Governor DeSantis' office inquiring about inclusion in FPL's Storm Secure Underground Program.

The decisions for inclusion in the program are based on the Florida Public Service Commission (FPSC) criteria relating to specific performance measures for our feeders. In selecting projects to be completed under the Distribution Lateral Hardening Program, FPL must follow the selection and prioritization criteria included in its FPSC-approved Storm Protection Plan. Under the FPSC-approved methodology, the selection and prioritization of the laterals to be converted are based on the following considerations:

- (a) all of the overhead laterals on each feeder;
- (b) outage experience during the recent hurricanes;
- (c) the number of vegetation-related outages experienced over the most recent 10 years; and
- (d) the total number of lateral and transformer outages experienced over the most recent 10 years.

All laterals on the feeders will then be hardened according to the ranking of each feeder. The FPSC-approved selection and prioritization criteria are applied on a non-discriminatory basis throughout FPL's service area to address the worst performing circuits first based on actual historical experience.

To further address your concerns, our Power Delivery team went out to investigate the circuits servicing Terra Mar Island last month. They also looked at the service report for the past year to see how the circuits are performing for the area. Their findings and an update on the work being done in accordance with our Storm Secure Plan to harden the infrastructure is as follows:

Over the past 12 months, the circuit that feeds the Terra Mar Island has experienced four interruptions, each caused by distinct issues. Two outages were due to Hurricane Debby and Hurricane Milton. One outage was caused by a substation breaker failure. The last outage was due to a vehicle impacting our facilities. Immediate corrective measures were taken, and the circuit was returned to its normal state.

FPL is in the process of hardening this circuit with anticipated completion by June 2025. Vegetation Management has completed planned circuit trimming in December 2024. Additional lateral section trimming, specifically in Lauderdale-By-The-Sea was completed February 2025.

FPL currently intends to continue this program until our entire grid is storm-hardened, including Lauderdale-By-The-Sea. This is an on-going program that is currently approved through 2032, which we just re-filed to extend through 2035. While the circuits serving your neighborhood of Terra Mar Island are not on the short-term horizon, it is a matter of time and prioritization in accordance with the approved selection criteria before these circuits are addressed.

Hi,

Please read this chain and see how the FPSC, your State Agency, seems to have abdicated its responsibility on one of its important programs to one of the very entities it was created to assure the public was protected.

As you can see from this chain of emails I have been very persistent in trying to bring attention to the need for our weather vulnerable barrier Town, Lauderdale by the Sea(LBTS)and then alternatively Terra Mar Island where I live, which is in both LBTS and the City of Pompano to be reviewed and placed on the eligibility list. From a weather vulnerability point of view it makes no sense that Pompano Beach , Fort Lauderdale, Light House Point are on the eligibility list but LBTS bounded by these communities, the ocean and the Intercostal waterway is not vulnerable enough to be placed on the eligible list.

Each time I have written to the authorities the rational for selection has never been based on data collected for eligibility but on the programs overall goal of placing local Governments on the eligibility list. Historically, unless it is a tornado, Florida weather patterns do not seem to have the same goal of passing up contiguous locations.

Further when I have contacted your office I have received the standard response that you receive many emails and can/will respond when time permits. Sorry but in the years when I have written to your office on this and other important statewide issues I have never received a response.

Thank you for remaining in the conversation on a very important safety topic for those of us living on barrier islands.

I sincerely believe a vulnerable neighborhood has little to do with the lines drawn by governments ; it still is a vulnerable neighborhood. The position that FPL has taken on Terra Mar Island does not promote a safe weather neighborhood when your criteria is based on local governments being placed on the eligibility list.

In the case of Terra Mar Island the history of outages during named storms, vegetation related outages and other reliable data cannot be considered because LBTS is not on the eligibility list even though many residents living on our Island are in the City of Pompano.

Good afternoon, Commissioner Graziano,

Thank you for your email. As stated in the letter, the Florida Public Service Commission (FPSC) approved selection and prioritization criteria are applied on a non-discriminatory basis throughout FPL's service area to address the worst performing circuits first based on actual historical experience. FPL must follow the selection and prioritization criteria set forth by the FPSC-approved Storm Protection Plan.

The analysis of feeder and lateral performance is not based on a municipal boundary but on the criteria considerations on the infrastructure that was outlined in the letter sent. The infrastructure for our entire service area, across the state, are submitted and reviewed annually. FPL currently intends to continue this program until our entire grid is storm-hardened, including the Town of Lauderdale-By-The-Sea. Please note that while the feeders for the neighborhood of Terra Mar are not on the short-term list for the Storm Secure Underground Program, it is an on-going program that is currently approved through 2032.

Hi,

Thank you for your Vice President's response to LBTS's request to be included on the FPSC/FPL SSUP hardening program.

I am not beating a dead horse but I suggest that Terra Mar Island is a "neighborhood" which is exactly what the program is designed to protect. Interestingly the 200 plus homes reside both in Pompano and LBTS. Does that mean the data supplied by FPL to become eligible for the list and therefore the program came only from Pompano?

Our homes on the Island are on the same feeder line from Pompano on AIA down across Terra Mar Drive across a bridge both in Pompano. When the last hurricane struck our Island "neighborhood" in LBTS and Pompano were all without power for over a week. Last years storms caused outages for days. All tree trimmings, pole replacements were/are Islandwide. There has been no hardening of the structures and we remain extremely vulnerable with old leaning poles etc, etc.

While not every neighborhood in LBTS may need the help from this program I suspect that is true for Pompano, Lighthouse Point and Ft. Lauderdale. The Terra Mar Island neighborhood is uniquely qualified and the FPL data should support that claim.

Why can't the Pompano eligibility be utilized to provide the underground service to the entire Island including the Pompano and LBTS residencies? The LBTS portion is landlocked by City of POMPANO, the Inter coastal waterway and the Terra MAR river.

While we realize all programs are designed to accommodate the ordinary circumstances but surely a situation such as Terra Mar Island were not contemplated but definitely need the weather mitigation upgrades offered to the house next door to others on the eligible list.
