**TAMPA ELECTRIC COMPANY'S REPORT ON STATUS  
OF TERRITORIAL AGREEMENT BETWEEN TAMPA ELECTRIC  
COMPANY AND THE CITY OF LAKELAND**

In Order No. PSC-92-0570-FOF-EU issued on June 25, 1992 in Docket No. 920251-EU the Commission approved the territorial agreement entered into by and between Tampa Electric Company and the City of Lakeland, Florida. Section 4.1 of said agreement calls for an annual report from Tampa Electric Company providing the status of the agreement and any modifications proposed in the agreement.

On March 18, 2014 Tampa Electric and the City of Lakeland filed a joint petition seeking the Commission's approval of a second amendment to their territorial agreement which makes some minor modifications to the territorial boundary between the two utilities to better enable them to provide electric service to their respective customers in the future. As the joint petition explained, no then current customers of either utility would be affected by the proposed territorial boundary modifications. That joint petition was approved as a matter of proposed agency action by Order No. PSC-14-0268-PAA-EU on May 28, 2014, followed by a Consummating Order No. PSC-14-0324-CO-EU issued in the same docket on June 24, 2014. Aside from the modifications effected by the second amendment, the agreement remains in full force and effect.

On December 23, 2024 Tampa Electric and City of Lakeland filed a Joint Petition for Approval of Temporary Services<sup>1</sup> in Docket No. 20240171-EU whereby the Joint Petitioners asked the Commission to approve Lakeland Electric's extending and providing retail electric service to Shaller Reserve Subdivision, currently in Tampa Electric's electric service territory, and Tampa Electric's extending and providing retail electric service to Phase 2 of Cadence Crossing, currently in Lakeland Electric's electric service territory. The Commission voted to approve Staff's

Recommendation approving the Joint Petition on March 4, 2025.<sup>2</sup> As of this date, the Commission has not issued a final order on the matter. Tampa Electric and the City of Lakeland are working on a comprehensive amendment to the existing territorial agreement and plan to file it in June of 2025.

The parties will continue to advise the Commission to the extent that any changes are proposed and will petition the Commission to resolve any disputes which may arise concerning the provisions of the agreement which the parties are unable to resolve.
