Watching the sewer issue come up over and over again by a for-profit business and a committee that recommends it despite the residents of Don Pedro Island being against it signals the standard government corruption from deep pocket interests. We've been residents for 13 years and coming to the island for 32. There are so many reasons why the current septic system should stay in place.

Our wildlife and simple life is what makes our island unique. Tearing it up, displacing wildlife is unnecessary when our current septic standard is working. This is a simple statement for a complex situation. You must know the island to understand how tearing it up would be devastating.

The financial burden of assessing homeowners in the interest of a for profit business is unconscionable! I'm assuming by the committee's recommendations those on the committee assume homeowners on an island are wealthy. Many of us saved up for a long time to buy rental property, reliant on rentals to keep the houses afloat. With the proposed increase in insurance this year, many homeowners will already be struggling beyond the repairs we're still trying to make from 3 hurricanes in 3 years. Forcing a needless assessment on them could put many of our homeowners on the brink of sale or foreclosure.

If you've been to the island, you'd know it's not like the other islands. It's quiet, quaint and is virtually untouched by commercialism. Our wildlife is vast and most streets unpaved. The destruction to add this unnecessary sewer system is exactly that, unnecessary!

Our septic systems have been in existence since the beginning. Many places around the country consistently use septic systems. Again, other than making a profit off the islanders, I'm not understanding why this topic continues to be replayed.

Our residents poured their hearts out to the committee and it appears from the recommendation, either the committee didn't listen or there are more nefarious actions behind the scenes. I am writing as a home owner on Little Gasparilla Island to voice my strongest possible opposition to the above docket for a sewer system on the Bocilla barrier Islands. There is absolutely no need for this system as no problem exists with the current management of sewage on these islands and the overwhelming majority of homeowners oppose it. In the words of President Reagan, "If it ain't broke, don't fix it". This proposal is a money making scheme for the FOR PROFIT Environmental Utilities who have NO experience with such a system. The costs would be passed on to us owners and is estimated to cost each home owners in excess of \$40,000, plus monthly fees once in place. They are proposing an outdated low pressure technology that Charlotte County won't install any more because of the excessive cost to maintain. These have a high failure rate and spillage of raw sewage into our delicate island and intracoastal environment will be disastrous for wildlife, the fisheries and tourism. I am writing to express my deep concern regarding the process undertaken by the Public Service Commission (PSC) in relation to Environmental Utilities LLC's (EU) application for a certificate to install a sewer system on Little Gasparilla Island.

An amendment filed and recorded in May 2024, Docket #20240032-SU, states:

BEFORE THE FLORIDA PUBLIC SERVICE COMMISSION IN RE: Application for certificate to provide wastewater service in Charlotte County, by Environmental Utilities, LLC DOCKET NO. 20240032-SU

ENVIRONMENTAL UTILITIES, LLC.'S AMENDMENT TO REDUCE REQUESTED SERVICE AREA

Environmental Utilities, LLC. ("EU"), by and through its undersigned attorneys, files this amendment to its application to delete certain property from its requested service area and states:

- 1. It was never the intent of EU to apply its septic-to-sewer project to Hideaway Bay and Placida Beach condominiums. These condominiums are served by a central wastewater treatment plant which is permitted by the Florida Department of Environmental Protection.
- 2. The owners of the units in these condominiums are not included in the number of prospective customers as set forth in the Application, and thus service to them is not included in any of the financial analyses.
- 3. Attached hereto are the legal descriptions of the two condominiums which are hereby deleted from EU's Application.

Despite this amendment, EU unilaterally altered the location of the wastewater transmission line from Don Pedro State Park to Hideaway Bay Beach Club (HBBC) property—without any notification to HBBC. While the docket states that HBBC is not required to connect, this change was made without due process or transparency. The transmission line's placement directly impacts all unit owners at HBBC, and EU failed to provide proper notification regarding this major modification.

Additionally, the newly proposed design includes a stub-out for the future connection of HBBC to the sewer system, despite HBBC operating its own DEP-approved wastewater treatment plant. The inclusion of this stub-out raises significant concerns:

- Why is HBBC being positioned for a future connection when it was explicitly removed from EU's application?
- What are the long-term implications and costs for HBBC, including potential expenses related to decommissioning our existing wastewater treatment plant?
- Why is privately owned property being impacted by a project we were led to believe would not affect us?

This situation is a clear violation of due process. Private property cannot be repurposed or encumbered without proper notification, justification, and transparency. This is not a matter of convenience—it is a matter of legal rights and property ownership.

Given these circumstances, I respectfully request that EU's application for a wastewater service certificate be denied. The lack of due process, the unauthorized modification of the transmission line location, and the potential forced connection of HBBC despite existing infrastructure all demonstrate significant issues with EU's proposal.

To the Commissioners of the Public Service Commission:

Tomorrow is a monumental day in the lives of Island residents. The decision you render regarding Environmental Utilities' application will impact the property owners within the prospective service area for many years to come.

In their recommendation, staff took the position that the application should be approved based on only the most limited factors to be considered. In other words, the application was complete and not deficient.

Staff also took the narrowest interpretation of what constitutes "need for service". They stuck to the 4 specific items in the application and dismissed any other considerations, such as environmental need for service, securing of easements and more.

As Commissioners of the PSC, we understand that you have the autonomy to consider more than the fulfillment of a checklist. There were only two items that differed from the previous docket where you denied certification:

• The inclusion of request for service with the application submission instead of later in the process.

• The submission of the Charlotte County supporting resolution with the application instead of a letter of support from Charlotte County that was submitted late in the process in 2022.

Nothing else has significantly changed since the last application.

We ask you to consider the following when making your decision regarding need for service/public interest. All can be verified in evidence and testimony:

• Environmental need is a part of the need for service. No testing has been done to prove water pollution, nor is there proof of a public health and safety issue.

• The Charlotte County resolution is not proof of a "need" for service, but rather it is a "want" for service as the Comprehensive Plan prohibits them from installing central sewer.

• EU's attorney wrote the Charlotte County resolution, not the Charlotte County attorney. That's why it states that there's no conflict with the Comprehensive Plan, when even the PSC staff agrees that there is.

• Even Charlotte County believes that a low-pressure system requires too much maintenance. They no longer use the system, only doing new installations where the system already exists.

• There is no mandate for central sewer, and Charlotte County continues to issue permits for septic system installations.

• The major discrepancies in the cost estimates among the various expert witnesses leaves the potential for a return to the PSC for a rate adjustment.

• The owners requesting service only represent 4% of the total ERCs. Everyone else who is aware of it opposes it.

Should this application be approved, the negative impacts will come without any demonstrable benefit or need. There will also be unintended consequences, as is always the case when a rubber-stamped solution is applied to a unique situation.

We respectfully request that you use the full extent of your authority to consider all of the factors in this case and deny this application.

Dear Commissioners,

Hi, our name is John & Beth Hofer. We own 2 condos on LGI at 9400 Little Gasparilla Island, Unit J2 and H10 which are part of the Hideaway Bay Beach Club condos. (HBBC). We are writing this letter to ask you to **deny** the application by Environmental Utilities for a certificate to install sewers on our island.

EU made the change to the location of the wastewater transmission line from Don Pedro State Park to the HBBC property. Even though we were excluded from the scope of this application on May 13, 2024 (Doc # 03001-2024) by EU's attorney, this change directly affects every one of the owners at HBBC. We were not notified of this substantial change to the application. This is a direct violation of one of the tenets by which the PSC should base their decision - proper notification of all involved parties. This change to the application without notification denies the owners at HBBC of our due process to be able to fight this change.

The letter from the HBBC lawyer, Nick Porter dated February 28, 2025 (Doc #01210-2025) also states HBBC's position in this matter. I was extremely disappointed that the PSC staff did not consider this oversight in their recommendation.

100+ Families are being denied their due process because of the change made by EU without notification.

If EU plans to use the model as indicated in the 2017 CC SMP, the pump house for the sewer will be built on the HBBC Septic Plant drain field. Building anything on our drain field will result in the community being shut down completely while the construction is underway. It will also force us to hook up to the EU sewer despite being excluded from the scope of this project. How can this be done without any kind of notification? Again, 100+ families are being denied our due process.

Because we were excluded from the scope of this application, there have been no estimates of the hook up costs for the condos. If this scenario plays out, HBBC would have to be the first people forced to hook up to the sewer system. We wouldn't have any recourse to this questionable action by EU, we wouldn't have any indication of the costs associated with this action, we wouldn't be able to use our homes resulting in additional living expenses and loss rental income until the initial sewer construction was completed and we would have to assume the costs of decommissioning our septic plant. Is this fair & reasonable for the 100+ families that are excluded from the scope of this application.

100+ families that are directly affected have not been notified. 100+ families currently using a DEP permitted septic plant do not need a sewer line brought to our property. 100+ families have no idea what the financial burden will be if this transmission line is brought to our property.

Hi, our name is John & Beth Hofer. We own 2 condos on LGI at 9400 Little Gasparilla Island, Unit J2 and H10 which are part of the Hideaway Bay Beach Club condos. (HBBC). We are writing this letter to ask you to **deny** the application by Environmental Utilities for a certificate to install sewers on our island.

EU made the change to the location of the wastewater transmission line from Don Pedro State Park to the HBBC property. Even though we were excluded from the scope of this application on May 13, 2024 (Doc # 03001-2024) by EU's attorney, this change directly affects every one of the owners at HBBC. We were not notified of this substantial change to the application. This is a direct violation of one of the tenets by which the PSC should base their decision - proper notification of all involved parties. This change to the application without notification denies the owners at HBBC of our due process to be able to fight this change.

The letter from the HBBC lawyer, Nick Porter dated February 28, 2025 (Doc #01210-2025) also states HBBC's position in this matter. I was extremely disappointed the PSC staff did not consider this oversight in notification in their recommendation.

100+ Families are being denied their due process because of the change made by EU without notification.

If EU plans to use the model as indicated in the 2017 CC SMP, the pump house for the sewer will be built on the HBBC Septic Plant drain field. Building anything on our drain field will result in the community being shut down completely while the construction is underway. It will also force us to hook up to the EU sewer despite being excluded from the scope of this project. How can this be done without any kind of notification? Again, 100+ families are being denied our due process.
