As I stated earlier in our phone conversation ALT & WLW will fund the pro-forma additions requested in the respective SARCs via annual operations (equity). There are no plans, currently, to secure a bank loan (debt) for these requests.

Additionally, at this point in time, Mike anticipates being at the June agenda for both SARC's. If those plans change we will let you know as soon as possible. Also, as I stated, we also plan to submit a request for additional rate case expenses incurred for both SARCs prior to your recommendation.
