Pursuant to Florida Administrative Code ("F.A.C.") Rule 25-22.006(3)(a), Florida Power & Light Company ("FPL") hereby files this Notice of Intent to Request Confidential Classification ("Notice"). This Notice relates to confidential information which Florida Energy for Innovation Association ("FEIA") has advised will be included within its direct testimony and exhibits of FEIA's witness Mohamed Ahmed, Ph.D. to be filed today, June 9, 2025.
