**EVGO SERVICES, LLC'S NOTICE OF SUBSTITUTION OF WITNESS AND
ADOPTION OF TESTIMONY**

EVgo Services, LLC ("EVgo") hereby notifies the Florida Public Services Commission and Parties of Record that EVgo will be sponsoring the testimony of a new witness, Alex Beaton, to adopt the prepared direct testimony filed by Noah Garcia on June 9, 2025 and that Mr. Garcia will not be a witness in this docket.

EVgo offers the following to promote administrative efficiency and assist all parties in accommodating this change. Contemporaneous with the filing of this notice, EVgo is serving three new or updated documents:

First, EVgo is serving a new version of Mr. Garcia's direct testimony titled "Direct Testimony of Alex Beaton." This testimony will contain no substantive changes to the testimony originally filed by Mr. Garcia. It will only reflect: (a) necessary changes to the name, title, qualifications, and experience portions of Mr. Garcia's testimony to update it with Mr. Beaton's information, and (b) the adoption of a new exhibit number AB-1 containing Mr. Beaton's CV to replace the original exhibit NG-1 containing Mr. Garcia's CV.

Second, EVgo's response to FPL POD 1 (seeking CVs of witnesses) refers parties to exhibit NG-1 for Mr. Garcia's CV. EVgo is serving an updated response to FPL POD 1 that now refers parties to exhibit AB-1 for Mr. Beaton's CV.

Third, the Direct Testimony of R. Thomas Beach filed on behalf of EVgo on June 9, 2025, references Mr. Garcia's testimony at 10:7-9. EVgo is serving a new document titled

Updated Direct Testimony of R. Thomas Beach that updates that reference to Mr. Beaton's testimony. No other changes were made to the testimony.

EVgo appreciates the cooperation of the Staff and Parties on this change and will work in good faith on any other clarifications or changes needed to accomplish the substitution and adoption described above.
