Dear Governor De Santis:

My name is Alan Ross and my address is 7437 S Highway A1A , Melbourne Beach Florida, 32951. I am a member of the Brevard Republican Executive Committee and I lead a county wide coalition of Republican and Conservative Groups called We the People of Brevard County. Our countywide coalition has over 600 members. I am writing you on their behalf.

Our Group has been studying the Green New Scam in Florida and we do not like what we see. Our Group overwhelmingly (98% plus) supports the rejection of PSC Docket 20250011, and we ask you to insert yourself upon the PSC and force them to REJECT FP&L's proposed \$9.0B rate hike.

This week we saw you at your **best** supporting President Trump's National Agenda with the work you and your team did with Alligator Alcatraz! We take note that if prior statements and actions are

consistent you should be aligned with President Trump and grassroots conservatives with fossil fuel friendly policies and support President Trump in promoting the reduction of solar and green energy projects under the "Big Beautiful Bill (BBB)."

Your Administration should continue to focus on economic growth, energy reliability and the conservative priorities of the people of Florida and in the face of federal incentive cuts for solar projects in the BBB we suggest you again support President Trump completely like you just did with Alligator Alcatraz. This massive rate request is a function of the Green New Scam agenda of the left and the citizens of Florida need your support in stopping this massive rate request driven by solar projects. We believe your support here would bring you the same media and fundraising boost you received with the Alligator Alcatraz project where you garnered over 3400 media mentions by July 1, 2025 and boosted fundraising for Florida Republicans. By aligning yourself with Trump on this issue and promoting the bill's anti-green energy stance would further elevate your national profile especially among voters critical of Federal spending on renewables.

We believe your best first step in supporting President Trump would be to kill the PSC Docket 20250011 rate request and send them back to the drawing board. We believe Florida needs a hardened 24/7 reliable energy grid to support the growth of Florida without blackouts and geometrically higher costs that would be passed on to the citizens of Florida and their businesses. We know you must recognize that the continuation of the support for Solar continues to benefit our greatest geopolitical adversary and competitor which is China. We also do not believe taking 10's of thousands of acres of farmland and green space for these absurd solar projects is in the best long-term interest of Florida!

Last, we ask you to consider and ponder the merits of allowing Florida allowed monopolies like Duke Energy and Florida Power and Light to receive campaign contributions. Think about it from the people's standpoint! They "have the business" so why do they need to contribute to campaigns and Political Committees? Let's face it they are trying to influence leadership in Florida to give them the highest returns at the expense of We the People" who are drowning in these Solar Rate increase requests.

So, we ask you to support President Trump and the great Citizens in the free state of Florida in this matter.

Our two requests in order of importance:

- 1) Deny the PSC Docket 20250011 rate request
- 2) Author legislation that prohibits energy monopolies like Duke Energy and Florida Power and Light donating money to Political Committees, Political parties and to Political Campaigns.

We believe these actions are in fact in the best interest of the people of Florida and our businesses!
