On October 6, 2025, Peoples Gas System, Inc. (Peoples or the utility) filed a request for confidential treatment for Document No. 14300-2025. This document contains confidential information from Peoples response to staff's first data request, No. 8. The confidential information contained relates to Peoples' Distribution Integrity Management Program (DIMP) plan.

In its request for confidentiality, Peoples asserts that disclosure of the information would cause harm to the utility, as the information relates to security measures, systems, or procedures.

Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Section 366.093(3)(c), Florida Statutes, whereby disclosure of the information would impair the competitive business operations of Peoples. Therefore, staff recommends the request by Peoples for confidential classification of Document No. 14300-2025 be approved.
