| 3  | Mr. Bethea, you like that, right? I got that        |
| 4  | right.  |
| 5  | MR. BETHEA: Yes, sir. That's it.                    |
| 6  | Good morning, Commissioners. Terence Bethea         |
| 7  | on behalf of Commission staff.                      |
| 8  | Item No. 7 is staff's recommendation                |
| 9  | addressing the correction of LP's test year         |
| 10 | operating revenues and rates approved by the        |
| 11 | Commission at the September 4th, 2025, Agenda       |
| 12 | Conference.   |
| 13 | Subsequent to the approval, it was discovered       |
| 14 | that the test year operating revenues were          |
| 15 | overstated, which understated the percentage        |
| 16 | increase to operating revenues. Since the           |
| 17 | percentage increase was applied across the board to |
| 18 | the rates at the time of the filing, the utility    |
| 19 | rates approved at the September 4th Agenda          |
| 20 | Conference do not allow LP to collect the approved  |
| 21 | revenue requirements of 197,112 for water and       |
| 22 | 149,156 for wastewater. The correction to the test  |
| 23 | year revenues results in increases of 10.97 percent |
| 24 | for water, and 9.92 percent for wastewater.         |
| 25 | Staff recommends that the rates at the time of      |

| 1  | filing be calcula recalculated across the board     |

| 2  | based on these percentages to allow the utility to  |
| 3  | collect the approved revenue requirement.           |
| 4  | There has been no customer contact in regards       |
| 5  | to this rate proceeding. The utility                |
