We have lived here since 2014.

We feel that if the first base facility charge by meter size is our size of 5/8 " by 3/4", we are willing to go from our current rate of \$5.74 to the Staff recommended rate to the \$9.11.

If we were any other meter price that is listed, I do not want to have to pay those prices.

If I am only using 3,000 gallons or less, like my manager told me we were.

I feel that the current rate of \$8.95 is good for us to be able to pay our bill.

The Staff Recommended Rate of \$37.01 is way too high for us to pay.

We just had an increase on our lot rent that was 5%, now that is \$40.00 more a month for us.

These prices are pricing us retired people with our limited incomes out on the streets.

Please put yourself in our place and realize we can't afford high rates like is on this paper or any more rent hikes every year like they have done to us.

We are not all "RICH" retired people. We live in a mobile home area where we thought we could afford to live.

To me living in a mobile home says we don't have the money to have a home in the Village area.

So please help us and don't raise prices on us that do live here.

We don't want people to smell like you know what if we can't pay our
