- 3) Stop letting FP&L and Duke Energy rely so heavily on gas plants and hand us the bill when fuel prices spike
- 4) Set aggressive, binding targets for solar and energy efficiency measures that lower costs for Floridian families

None of this is experimental. None of this requires waiting. What it requires is leadership — and the political will to prioritize ratepayers over shareholders. Floridians like me are watching, and we expect you to act like you work for us. Thank you for your consideration.
