6. I have reviewed Rule 28-106.107, Florida Administrative Code, and agree to abide by its standards.

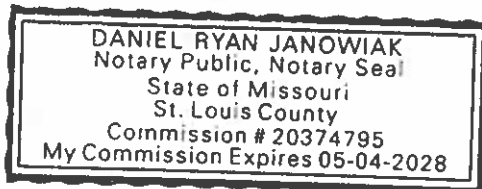

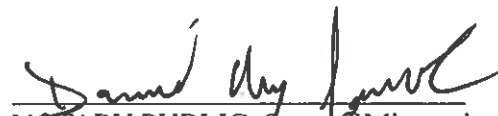
