Dear Mr. Teitzman:

Sunshine Water Services Company ("SWS" or the "Company") gives notice of and requests that the Florida Public Service Commission ("FPSC" or the "Commission") acknowledge the corporate reorganization described below. The name and address of the Company is: Sunshine Water Services Company, 200 Weathersfield Avenue, Altamonte Springs, FL 32714-4099.

SWS is a Class A water and wastewater utility certificated by the Commission and is regulated under Chapter 367, Florida Statutes. The Company provides potable water and wastewater services to over 35,000 and 30,000 customers, respectively, across Charlotte, Highlands, Lake, Lee, Marion, Orange, Pasco, Pinellas, Polk, and Seminole Counties, Florida. SWS holds water and wastewater certificates issued by the FPSC as shown on **Exhibit A**.

SWS is a Florida corporation and a wholly owned subsidiary of Nexus Regulated Utilities, LLC ("NRU"), which is an indirectly¹ wholly owned subsidiary of Nexus Water Group, Inc., headquartered at 2150 Town Square Place, Suite 400, Sugar Land, Texas 77479 ("NWG"). A simplified organizational chart showing SWS's place in the current Nexus family of companies is shown on **Exhibit B**.

As part of a general corporate reorganization to be effective July 1, 2026, SWS will become a wholly-owned subsidiary of Florida Water Holdings, Inc. ("FWH"), which is a wholly-owned subsidiary of Southeast Utility Systems, Inc. ("SUS"), which is a wholly-owned subsidiary of SouthWest Water Company, LLC ("SWWC"), which is a wholly-owned subsidiary of NWG. Accordingly, after the reorganization, although the ownership chain will

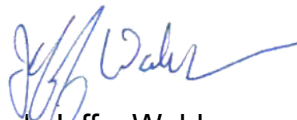
shift from the NRU chain to the SWWC chain, SWS will continue to be an indirectly wholly-owned subsidiary of NWG.² A simplified organizational chart showing SWS's place in the Nexus family of companies after the reorganization is shown on **Exhibit C**.

This corporate reorganization will facilitate future financing activities and better align the Nexus operating utilities within its management structure. The reorganization will not involve a name change for SWS. There will be no changes to the Company's operations and service, management team, office address, telephone number, tariffs, or customer rates and charges. The affidavit of SWS President and CEO Sean Twomey attached as **Exhibit D** attests that this reorganization will not change the ownership and control of the Company. SWS will continue to be a wholly owned subsidiary of Nexus Water Group, Inc. and a part of the Nexus family of companies.

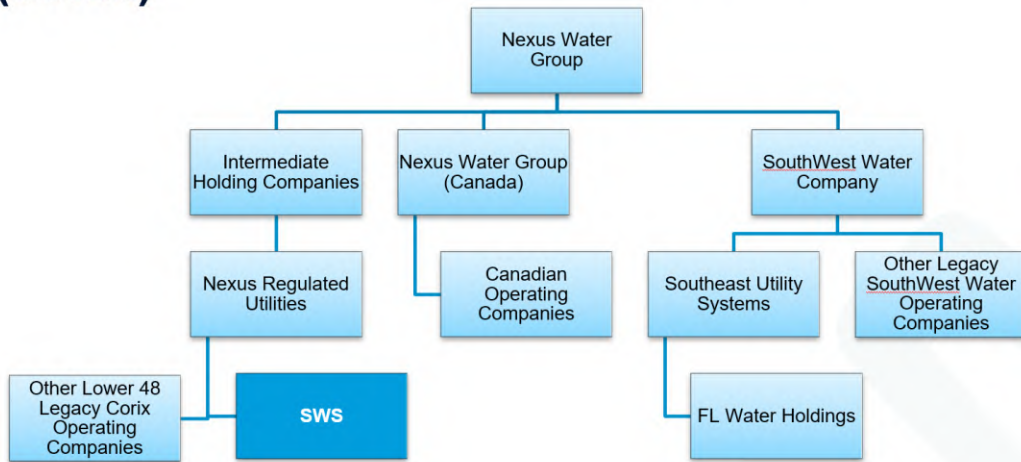

Simplified Organizational Structure**

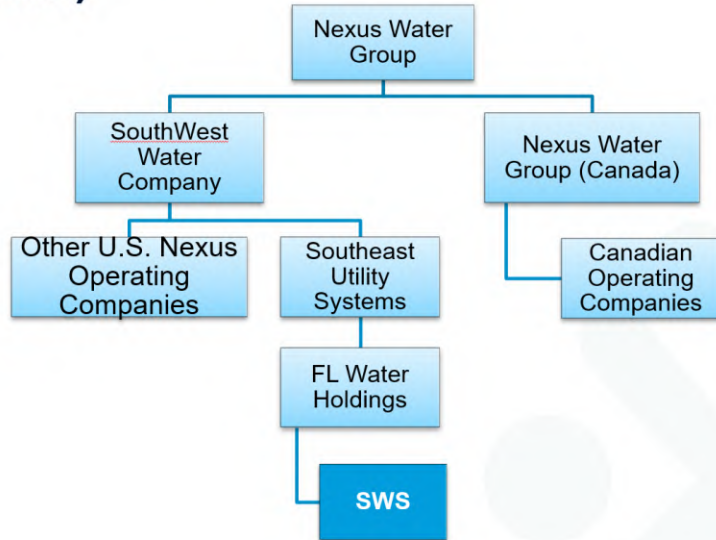
**Nexus Simplified Organizational Chart – Current

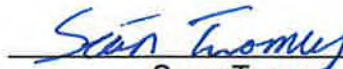

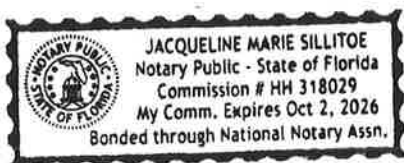

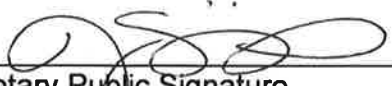
