Overview

The Business Feature Promotion is scheduled to begin 1/4/2010 and end on 12/31/2010. This is a feature (vertical services/hunting) promotion for customers subscribed to Business Local Calling Assurance.

Promotion Specifics

Eligible customers may receive a 50% monthly discount based on the stand alone tariff rate for up to ten (10) of the following services per line: Call Forward Busy Line, Call Forward Don't Answer, Three Way Calling, Speed Calling 8, Speed Calling 30, Call Waiting, Call Return, Repeat Dialing, Ringmaster, Call Block, Anonymous Call Rejection, Call Selector and Hunting. Additionally, a waiver of normally applicable service charges associated with the addition of these services may be provided.

Promotion Restrictions/Eligibility Requirements

This offer is available only for subscribers to Business Local Calling Assurance and will be available to win/winback, save and existing AT&T business customers.
