This transfer involves placing the entire San Destin Resort in the Destin exchange, allowing the entire development to be served from the Destin exchange. Enclosed is a copy of the customer letter notifying the affected customers of this change and requesting they determine their preferred service exchange. Thirty-one customers in the area being transferred have requested a change to Destin service. The remainder of the notified customers are filed as local exchange exceptions so that they may continue to receive service from the Santa Rosa Beach exchange.

Dear Sprint Customer:

To keep up with the continuing growth in Okaloosa and Walton Counties, Sprint is expanding the Destin exchange boundary to include the portion of the Santa Rosa Beach exchange where you are currently being served. With this change, you will have the option to change your telephone service to a Destin exchange service telephone number or continue your Santa Rosa Beach exchange service telephone number.

The following information, regarding the rates and local calling areas of the two exchanges, has been prepared to assist you in determining which service you would prefer:

Your Current Santa Rosa Beach exchange rates and local calling areas:

Santa Rosa Beach Residence Service:	\$10.21
Santa Rosa Beach Business Single Line Service:	\$21.06

(rates do not include taxes, surcharges or any special features)
(other residence and business rates will vary based on the type of service provided)

Calls to Destin, Fort Walton Beach and Seagrove Beach numbers are local calls
Calls to Defuniak Springs, Freeport, Glendale, Ponce de Leon and Valparaiso are \$0.20 per call for residence service and \$0.20 per first 60 minutes of each call then toll rates for additional minutes above 60 minutes for business service.
Calls to Baker, Crestview and Shalimar are toll calls. Rates depend on your long distance carrier.

Calls to Fort Walton Beach, Santa Rosa Beach, Shalimar and Valparaiso are local calls

Calls to Baker, Crestview, Defuniak Springs, Freeport, Glendale, Ponce de Leon and Seagrove Beach are \$0.20 per call for residence service and \$0.20 per first 60 minutes of each call then toll rates for additional minutes above 60 minutes for business service.

If you elect to receive service from Destin, a telephone number change will be required. There will be no charge for changing the number. If you elect to change to a Destin exchange service telephone number, your new Destin number will become effective on September 15, 2004. Your existing Santa Rosa Beach telephone number will be put on a recorded referral to your new Destin number for eight months.

If you want to change to a Destin service telephone number, please use the enclosed form and return it in the enclosed pre-addressed business envelope by July 21, 2004. If we do not hear from you, your service will remain with your current Santa Rosa Beach number. Residential customers can call Sprint Customer Service at 1-800-339-1811 and business customers can call 1-800-786-6272 with any questions.
