First Coast Regional Utilities, Inc. ("First Coast"), pursuant to rule 1.340, Florida Rules of Civil Procedure, responds to Staff's Eighth Set of Interrogatories to Applicant, as follows:

INTERROGATORIES

53. If you were to calculate corresponding accumulated deferred income taxes for the plant additions reflected in Exhibit DDS-1, what would the tax depreciation rate be?

Response: First Coast has not retained a tax accountant to provide this information. However, First Coast's position is that PSC policy is not to include ADITs associated with depreciation in original certificate applications, and that there is a lack of specificity in the parameters necessary to make this onerous calculation.
