The model combines wind and in-service asset data to produce damage result information. The wind data is based on the National Hurricane Center (NHC) forecast track and intensity, while the in-service asset data is provided by FPL's Asset Management System (AMS) and includes infrastructure improvements from storm hardening. The model uses multiple Monte Carlo simulation runs to estimate damage based on the all available information about the infrastructure. The model incorporates data regarding vegetation, pole loading, soil conditions, and storm surge. The algorithms used in FPL's Storm Damage Model are tested, updated, and verified twice a year.
