PROMOTION DESCRIPTION

BellSouth Additional Line with Fast Access DSL Promotion

PROMOTION OVERVIEW

This promotion offers existing BellSouth business subscribers who purchase an additional line (a la carte or in a Complete Choice for Business package) in conjunction with a new or additional FastAccess DSL service, a one-time seventy-five dollar (\$75.00) bill credit reward. Subscribers must also require jacks and wiring to receive the bill credit reward. To be eligible for the bill credit reward, the subscribers who contact or are contacted by BellSouth must request information on local exchange service for comparison with competitive offers, or otherwise if necessary for the customer to agree to purchase service from BellSouth.
