PROMOTION DESCRIPTION BellSouth Business Shoppers Promotion

PROMOTION OVERVIEW

The Business Shoppers Promotion will offer subscribers a one-time non-recurring one hundred dollar (\$100.00) coupon redeemable for cash. To be eligible for the coupon, the subscribers who contact or are contacted by BellSouth must request information on local exchange service for comparison with competitive offers, or otherwise if necessary for the customer to agree to purchase service from BellSouth. Coupons available while supplies last. This promotion began on September 1, 2005 and ended on December 31, 2005, and is extended until April 30, 2006.

PROMOTION SPECIFICS:

- 1. Available only to new (acquisition/reacquisition) BellSouth business customers subscribing to a Complete Choice for Business Line Package.
- 2. Subscribers that request information on local exchange service for comparison with competitive offers, or otherwise if necessary for the customer to agree to purchase a Complete Choice for Business Line package.
- 3. Subscriber agrees to keep local services Complete Choice for Business Line Package with BellSouth for a minimum of 12 months from the enrollment date in the Promotion.
- 4. All Subscribers who ask or otherwise qualify shall receive a coupon.
