Frame Relay to NetVPN Migration Promotion

OVERVIEW OF PROMOTION:

BellSouth plans the following Frame Relay to NetVPN Migration Promotion that will begin on May 1, 2006 and end on July 28, 2006. Standard termination liability charges associated with BellSouth Frame Relay service circuits will not be applicable for qualifying subscribers who sign a twenty-four (24) month or longer agreement for a BellSouth NetVPN service circuit as a replacement for a BellSouth Frame Relay service circuit which has been installed for twelve (12) months or longer.
