# **Promotion Description**

# Florida - Large Business PRI Advantage Promotion (Extension)

#### **Overview**

The Large Business PRI Advantage Promotion *is being extended an additional six months* with *an end date of December 31, 2006*. Customers subscribing to Large Business PRI Advantage will receive a waiver of installation charges and a discount on B channel monthly recurring rates. B channel rates will be based upon the length of the term agreement.
