Retention \$5 for 12 Month Promotion

Overview

The Retention \$5 for 12 Month Promotion promotion is scheduled to begin on 06/01/2008 and end on 1/31/2009. Customers who call to disconnect service with AT&T and elect to stay and have/purhcase 2Pack or above are eligible to receive a \$5 bill credit for 12 months.

Customers who have or add any package that has 2Pack or the components of 2 Pack are eligible. (BPP and CC).

Offer will be available in AL, GA, FL, LA, KY, MS, NC, SC, TN.

Promotion Specifics

Customers who call to disconnect service with AT&T and elect to stay and have/purhcase 2Pack or above are eligible to receive a \$5 bill credit for 12 months.

Customers who have or add any package that has 2Pack or the components of 2 Pack are eligible. (BPP and CC).
