AMENDATORY ORDER

BY THE COMMISSION:

On November 14, 1991, this Commission issued Order No. 25347 which established rates and charges. Schedule 4, the calculation of the rate reduction, was inadvertently omitted and is appended hereto. Also, the Section denominated Customer Reclassification on page 9 contains scrivener's errors and thus should be deleted and replaced with the following language:

Customer Reclassification and Adjustment for Improper Billing for Wastewater

Our audit of the utility's billing procedures revealed that five general service water accounts were billed as residential accounts and were incorrectly billed for wastewater service. These accounts contain billing information for water usage provided for landscaping needs at the back gate, the marina and Lake Serenity areas, as well as, water for two drinking fountains on the golf course. None of these sites are connected to the wastewater collection system. The utility was made aware of its billing error and is in the process of reclassifying the water accounts to general service, crediting the customer's for the incorrect billing for accounts wastewater service and deleting the wastewater The water revenues were not accounts. affected by the reclassification because the rates are the same for both classes of water service. As a result of the incorrect billing for wastewater service, we find it appropriate to reduce wastewater revenues by \$571.
