ORDER APPROVING WEST FLORIDA NATURAL GAS COMPANY'S  
FINANCING APPLICATION

BY THE COMMISSION:

Pursuant to Section 366.04, Florida Statutes, an application was filed on August 17, 1992, by West Florida Natural Gas Company (West Florida) seeking authority to obtain new lenders and extend the term of its loans previously approved by this Commission in Dockets Nos. 900564-GU and 920620-GU. In Docket No. 920620-GU the Commission approved West Florida's request to issue \$3 million in long-term debt and to increase of its line of credit to \$1.5 million. According to West Florida, it will seek to refinance the financing previously approved by this Commission in Dockets Nos. 900564-GU and 920602-GU so that all obligations will be held by the same lender.

Having reviewed the application, we find that it should be granted. It is therefore

ORDERED by the Florida Public Service Commission that West Florida Natural Gas Company's financing application as described in the body of this Order is approved. It is further

ORDERED that West Florida Natural Gas Company shall file consummation reports in compliance with Rule 24-8.009, Florida Administrative Code, within ninety days after issuance of the securities authorized by this order. It is further

ORDERED that the foregoing authorizations without prejudice to the authority of this commission with respect to rates, service, accounts, evaluations, estimates or determinations of costs, or any other matter whatsoever pending or which may come before this commission, as approved in Section 366.04, Florida Statutes.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
