PROMOTION DESCRIPTION BellSouth 3 for 3 Reward Promotion

PROMOTION OVERVIEW

In accordance with the appropriate section of the General Subscriber Services Tariff, BellSouth plans the following promotion. BellSouth 3 For 3 Reward Promotion is available to new (acquisition/reacquisition) BellSouth business subscribers located in the BellSouth region in all states. The 3 for 3 Reward Promotion will offer subscribers that are under any type of term agreement or contract with another local exchange provider, a one-time, non-recurring check for three hundred dollars (\$300.00) when subscribing to local exchange service with BellSouth. This promotion began September 1, 2005 and will end April 30, 2006.

This promotion is being updated, effective January 1, 2006, to increase the maximum eligible aggregate annual BellSouth spending from the current \$42,000 per year per state to \$65,000, and to include Complete Choice for Business Elite Promotion (where available) as an eligible promotion.

PROMOTION SPECIFICS:

- 1. Available to new (acquisition/reacquisition) BellSouth business customers subscribing to local exchange service that have an existing term agreement or contract with another local exchange provider.
- 2. Subscriber must purchase a minimum of 3 lines per new location to be eligible.
