## **Promotion Description**

### SBS Bundle Incentive Promotion Modification

#### <u>Overview</u>

BellSouth plans to modify the Bundle Incentive Promotion to add a Wireless Bonus effective September 1, 2006. All other elements of this promotion will remain unchanged. The Wireless Bonus will require Cingular Wireless activation.

#### **Promotion Modification**

The Bundle incentive Promotion will be modified to add a Wireless Bonus as follows:

Existing business subscribers who select Option 3 or Option 4 as defined in this promotion (new Complete Choice® for Business package, new 36 month BellSouth local exchange term agreement, new BellSouth Long Distance Inc. BellSouth Business Unlimited Plan ("Business Unlimited Plan"), and/or new BellSouth FastAccess® Business DSL service ("FastAccess DSL") 384K speed or higher) and activate new Cingular Wireless will receive a twenty-five dollar (\$25.00) one time bill credit. This credit will appear in the OC&C section of the subscriber's bill within thirty (30) to forty-five (45) days of Cingular activation and will only be applicable to non-basic services. This bill credit will be at the account level and only one (1) credit is allowed per account. This wireless bonus will only apply to new Cingular activations. Customer must meet Cingular wireless plan and equipment. This bonus requires a 12 or 24 month Cingular contract. Customer must purchase in accordance with SBS credit card policy. Combined billing of Cingular charges to SBS billing is required for this wireless bonus.
